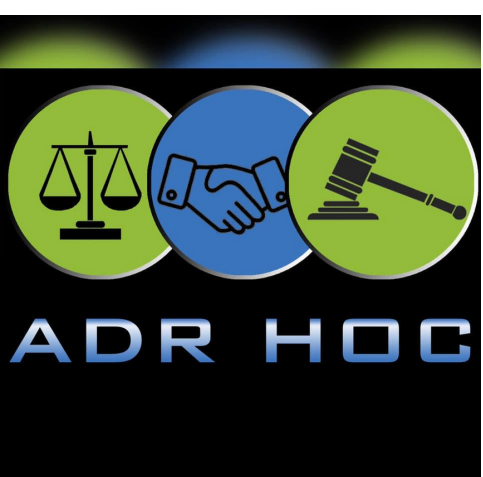

# **SUBMISSION GUIDELINES**

1. Word limit for the Session Proposal: 400-500 words
2. The length of full paper including tables, diagrams, illustrations, references, etc. should be 3500-8000 words. The paper should be typed in Times New Roman, font size 12 with 1.5 linespacing.
3. The footnotes must be typed in Times New Roman, font size 10 with single spacing. The margin of 1 inch on all sides must be maintained throughout the paper.
4. Bluebook 20th Edition shall be strictly followed for Footnoting and referencing.
5. The session proposal and the full paper should be submitted in soft copy and shall be sent to [adrconference2020@gmail.com](mailto:adrconference2020@gmail.com) with the subject line "Full Paper – International Conference".
6. All submissions should be sent in .doc/.docx format only.
