Terms and Conditions

- 1. The competition is open for school students of classes 8th 10th; 11th & 12th and college students (under graduation) of India only.
- 2. All entries must be submitted on www.mygov.in. Entries submitted through any other medium/mode would not be considered for evaluation.
- 3. A participant can send one entry only. In case it is found that any participant has submitted more than one entry, all the entries will be considered as invalid.
- 4. The entry should be original. Copied entries will not be considered under the contest.
- 5. The participant must be the same person who has written the write-up and plagiarism would not be accepted.
- 6. Please note that the Essay must be original and should not violate any provision of the Indian Copyright Act, 1957.
- 7. Anyone found infringing on others' copyright would be disqualified from the competition. Government of India does not bear any responsibility for copyright violations or infringements of intellectual property carried out by the participants.
- 8. Mention of the author's name/emails, etc. anywhere in the body of the essay will lead to disqualification.
- 9. Entry must be submitted in clear, readable and downloadable **PDF format only**.
- 10. Participants are to make sure that their <u>MyGov Profile</u> is accurate and updated since Ministry of Health & Family Welfare would be using this for further communication.
- 11. Participants are required to fill and share the **Participant Form** which includes details such as name, photo, complete postal address, email ID, phone number (mobile), class, school/college name and address of the school/college.
- 12. Participants are to make sure that they share both their entry and Participant Form. Entries with incomplete profiles would not be considered.
