## MAIN THEME OF RESEARCH PRESENTATIONS

ALTERNATE DISPUTE RESOLUTION has come to rescue the courts from its burden of everincreasing stack of cases. Our Judiciary has come to realize the importance of ADR and how it is the need of the hour that cases got settled outside the court. The increasing FDI and Cross-Border Trades have called this ADR mechanism to come handy to solve disputes. ADR mechanism entails methods in approach of Arbitration, Conciliation, Mediation, Negotiation, and Lok Adalat and provides the parties to pursue either approaches so as to resolve dispute outside the court amicably. This Call for Research Presentations will be fruitful considering the need to augment awareness about the mechanism of ADR due to the pandemic which has come to prove the importance of ADR in difficult times. #### SUBMISSION GUIDELINES

#### **ABSTRACT:**

- The abstract shall not exceed 500 words. It should include the Title, Keywords, the Presenter's Name, Designation, Institutional Affiliation, Mailing Address, Contact Number and E- mail ID.
- 2. The abstract should be typed in Times New Roman, font size 12 with 1.5 linespacing.
- 3. Bluebook 20<sup>th</sup> Edition/APA shall be strictly followed for Footnoting and referencing.
- 4. The abstract shall be submitted through registration link only. All submissions should be uploaded in .doc/.docx format only.
- 5. Co-authorship is limited to a maximum of two authors.
- 6. That the Abstract is the only criteria upon which selection for the Presentation before the Learned Panel is based.

Intimation for acceptance/improvisation will be provided within 2 working days from the last

date of the submission of abstract.

#### **FULL PAPER:**

Since the event is being conducted during days where the Universities and the Law Schools would be fully functional, to accommodate the opportunity of Call for Research Presentations, ADR HOC is requiring the Participants to submit PowerPoint Presentations (PPT), rather than full length papers/research. PowerPoint Presentations (PPT)shall be considered as the Final Submission by the selected Participants.

- One (1)Best Presentation will be acknowledged from each session. Certificates of Achievement shall be given to such Presenters.
- All the Participants shall be provided with E-certificates.

Presenters are solely responsible for the creation of their presentation. The presentation should be based on the approved/accepted abstract but may include updates and related additional content. Only the listed presenters may present their abstract.

# For a successful and productive conference, all presenters should adhere to the following guidelines:

- PowerPoint Presentation (PPT) is encouraged for presentation at the conference. If giving power Point Presentation (PPT), presenter(s) should save their presentation in .pdf or .ppt format and present it through the screen sharing mode.
- All presentations are to be in English. The presenter(s) should be able to understand and respond to audience questions in English.
- Presentations should be of 8-10 minutes which shall be inclusive of 3 minutes for questions. Participants need to join the session 15 minutes before it begins and be well prepared with the presentation. Any unnecessary delay on part of the participant might lead to disqualification.
- It is suggested for presenter(s)/ attendee(s) to dress professionally.
