Required Assistant Professor (One Post) on Contract Basis for School of Livelihoods and Development, TISS- Hyderabad Off Campus

The Tata Institute of Social Sciences (www.tiss.edu), established in the year 1936 is a Deemed to be University, fully funded by the University Grants Commission, Govt of India. TISS is a Grade I University with NAAC score of 3.89/4 and NIRF 2021 rank of 37 among Indian Universities and 70 overall.

With campuses at Mumbai (Main) and off-campus at Tuljapur, Guwahati and Hyderabad, TISS offers over 50 Post Graduate programmes, 18 Doctoral programmes, and 3 Under Graduate programmes in a range of socially relevant inter-disciplinary and applied social science disciplines, and over 30 B.Voc. programmes.

Freedom and autonomy shape the positive work ethos and culture of the Institute and facilitate strong linkages between teaching, research, field action and policy engagement. The Institute encourages and supports researchers to engage in foundational, applied, field and action-oriented research, and nurtures research collaborations nationally and internationally, with a commitment to creating a just society through education, generation of knowledge and field action initiatives.

The School of Livelihoods and Development in Hyderabad Off Campus offers three master's programmes (Development Studies, Rural Development and Governance, Natural Resources and Governance) and has a mandate to create a cadre of human service professionals who through their multi-disciplinary training respond to current development challenges and incubate ideas to proactively meet future demands of the society.

The school invites applications from interested scholars for **ONE post of Assistant Professor** at the **School of Livelihoods and Development** to lead the teaching and research programmes in the areas of **gender and development** besides teaching courses. The post will be on contractual basis initially for a period of one year and extendable based on the performance of the candidate and requirement of the institute.

Remunerations: Consolidated Pay @ Rs. 71952/- p.m. (Pay Band Rs. 15600 – 39100; AGP Rs. 6000/-).

Educational Qualification:

Eligibility (A or B):

A.

i) A Master 's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in **Economics/Development Studies** or an equivalent degree from an Indian University, or an equivalent degree from an accredited foreign university.

ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET:

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET /SLET /SET for recruitment and appointment of Assistant Professor subject to the or equivalent positions in

Universities/Colleges/Institutions fulfilment of the following conditions: -

- a) The Ph.D. degree of the candidate has been awarded in a regular mode; b) The Ph.D. thesis has been evaluated by at least two external examiners; c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
- e) The candidate has presented at least two papers based on his/her Ph.D work in conferences/seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.

The fulfilment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

Note: NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

OR

B. The Ph.D degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) theTimes Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

The desirable qualifications and experience:

The candidates having Ph.D. in Economics/Development Studies or any applied social science discipline with a focus on gender and development, women and work, inclusive development, informal sector and familiar with large data sets (NSSO, Census, NFHS etc.) and their use to understand the gender issues in India will be given preference. Candidates with sound knowledge/experience of quantitative/qualitative research methods and good publication record will be preferred.

Candidate selected to this position will contribute to teaching, student mentoring, research projects at the TISS Hyderabad off campus. Besides teaching courses across the programmes in the Institute, the candidate should also be willing to work in a team and explore new and emerging research areas. Candidate selected should be willing to take responsibilities of coordination of workshops, experiential learning and other academic administration as may be required from time to time.

Other Conditions:

- The Institute reserves the right to relax qualification of the candidate based on the work experience and to relax age in the case of persons already holding comparable positions in a University/Research Institution of repute.
- The Institute reserves the right to invite persons for interview who may not have applied for as per the above procedure and not fill up the vacancy advertised.
- Since applications received may be short listed, merely possessing the prescribed qualifications and the requisite experience would not entitle a person to be called for interview.
- The post is unreserved, but candidates belonging to reserved category can apply.
- No queries or correspondence regarding issue of call letter for interview/selection of candidates for the post will be entertained at any stage and canvassing in any form is strictly prohibited and will lead to the candidate being debarred from consideration for the post.
- The candidate under employment must bring 'No Objection Certificate' from their employer to appear for presentation/interview.
- No TA/DA is payable for appearing for the interview.

Application Fee: The application fee of Rs. 1000/- be paid on-line. The application fee for SC/ST/PWD candidates will be Rs. 250/- if they attach the required certificate to the online application form. The women applicants are waived from payment of application fees. The application will be valid only on receipt of the application fee, if applicable. Fees once paid shall not be refunded under any circumstances.
