Required Assistant Professor (One Post) on Contract Basis for Jamsetji Tata School of Disaster Studies at TISS-Mumbai Campus.

With campuses at Mumbai (Main) and off-campuses at Tuljapur, Guwahati and Hyderabad, TISS offers over 50 Post Graduate programmes, 18 Doctoral programmes, and 3 Under Graduate programmes in a range of socially relevant inter-disciplinary and applied social science disciplines, and over 30 B.Voc. programmes.

The Institute encourages and supports researchers to engage in foundational, applied, field and action-oriented research, and nurtures research collaborations nationally and internationally, with a commitment to creating a just society through education, generation of knowledge and field action initiatives.

The JTSDS of TISS invites applications for the post of Assistant Professor to be filled on contract basis for a period initially upto May 31, 2023 and extendable based on the requirement by the Institute. **The candidates those have applied to this post based on the advertisement no. TISS/ADVT/July/2022 dated 07 July 2022 need not apply again.** Their applications shall be considered as per the rules.

Remunerations: Consolidated Pay @ Rs. 71952/- p.m. (Pay Band Rs. 15600 – 39100; AGP Rs. 6000/-).

Eligibility Criteria:

Educational Qualification: Eligibility (A or B):

A.

i) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in **Disaster Management / Planning / Climate Change / Sustainability Studies/ Public Policy/ Statistics / Analytics / Engineering** from an Indian University, or an equivalent degree from an accredited foreign university.

ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET:

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of 'Assistant Professor' subject to the or equivalent positions in Universities/Colleges/Institutions fulfilment of the following conditions:-

The Ph.D. degree of the candidate has been awarded in a regular mode;

The Ph.D. thesis has been evaluated by at least two external examiners;

An open Ph.D. viva voce of the candidate has been conducted;

The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a referred journal;

The candidate has presented at least two papers based on his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.

The fulfilment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

Note: NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

OR

B. The Ph.D. degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following:

Quacquarelli Symonds (QS)

the Times Higher Education (THE) or

the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

The desirable qualifications and experience:

The candidates having minimum of one year of work experience/research/teaching in the area of disaster management/ Climate Change / Sustainability Studies shall be given preference. Those possessing relevant publications and experience in risk assessment and hazard modelling/analytics are preferred. Candidates with demonstrated competence for inter-disciplinary teaching and research are encouraged to apply. Proven capacities to write high quality research proposals to secure national and international funding will be an asset.

Other Conditions:

The Institute reserves the right to relax qualifications of the candidate based on the work experience.

The Institute reserves the right to invite persons for interview who may not have applied for as per the above procedure and not fill up the vacancy advertised.

Since applications received may be short listed, merely possessing the prescribed qualifications and the requisite experience would not entitle a person to be called for interview.

The post is unreserved, but candidates belonging to reserved category can apply.

No queries or correspondence regarding issue of call letter for interview/selection of candidates for the post will be entertained at any stage and canvassing in any form is strictly prohibited and will lead to the candidate being debarred from consideration for the post.

The candidate under employment must bring 'No Objection Certificate' from their employer to appear for interview.

Application Fee: The application fee of Rs. 1000/- be paid on-line. The application fee for SC/ST/PWD candidates will be Rs. 250/- if they attach the required certificate to the online application form. The women applicants are waived from payment of application fees. The application will be valid only on receipt of the application fee, if appliable. Fees once paid shall not be refunded under any circumstances.

The candidates are requested to take a print of the acknowledgement of the online application and keep it for future reference.

The last date for submission of online applications will be 20 August 2022.

The shortlisted candidates will be sent a call letter and link for the online interview to be held on 27 August 2022.

Verification of documents: The shortlisted candidates are required to send scanned copies of their coloured passport size photograph, self-attested photocopies of relevant certificates in support of the essential qualification & experience. Original certificates will be verified only for the selected candidate at the time of appointment.

Note: The selected candidate would be required to join within 15 days of selection and must be stationed in Mumbai.
