ABOUT

Indian Society of Victimology

The Indian Society of Victimology (ISV) is a national level professional society that was founded in 1992 under the aegis of Professor K. Chockalingam, the then Head of the Department of Criminology, University of Madras along with senior police officers Dr. R. K. Raghavan and Mr. L. N. Venkatesan. The Society was formally inaugurated by the eminent jurist, late Hon'ble Mr. Justice V. R. Krishna Iyer, Former Judge of the Supreme Court of India. Over the last 27 years, the Society has made significant contributions towards victims' rights as enshrined in the UN Declaration of Basic Principles of Justice for Victims of Crime and Abuse of Power, 1985, advocating the cause of victims of crime and abuse of power in India and abroad through its conferences, workshops, seminars, and symposia on a wide range of victimological topics. The members of the Society come from a global fraternity of criminologists, victimologists, government officials, criminal justice stakeholders, scholars, students and practitioners.

Rajiv Gandhi National University of Law, Punjab

The Rajiv Gandhi National University of Law (RGNUL), Punjab, was established by the State Legislature of Punjab by passing the Rajiv Gandhi National University of Law, Punjab Act 2006 (Punjab Act No. 12 of 2006). The Act incorporated a University of Law of national stature in Punjab, to fulfil the need for a Centre of Excellence in legal education in the modern era of globalization and liberalization. The University acquired approval of the Bar Council of India (BCI) in July 2006. The University also got registered with the University Grants Commission (UGC), New Delhi under Section 2(f) of the University Grants Commission Act, 1956 and has been declared fit to obtain grant from the (UGC) under Section 12-B of the UGC Act, 1956. The University was accredited with 'A' Grade by National Assessment and Accreditation Council (NAAC) in 2015. RGNUL, Punjab was granted autonomy under UGC Regulations, Clause 5 Dimensions of Autonomy for Category-II Universities in April 2018. The Ministry of Human Resource Development, Government of India, ranked RGNUL the first amongst the cleanest Higher Educational Institutions, Swachh Campus (2019) in the category of Government Residential Universities.

The Centre for Criminology, Criminal Justice and Victimology (CCV) has been set up at Rajiv Gandhi National University of Law, Punjab for advanced research, training, policy analysis and consultancy in the areas concerning criminology, criminal justice and victimology. 2. An Abstract of **300 words (Max.)** should be sent on or before **20th August 2022**.
3. Acceptance of abstract will be communicated within **15 days after submission**.

5. A full paper not exceeding 5,000 words should be sent on or before **20th September 2022** upon acceptance of the abstract.

Awards of the Indian Society of Victimology and Guidelines to Apply

(A) Professor K. Chockalingam Award

1. The highest award of the ISV is presented in honour of Professor K. Chockalingam. The award carries a plaque, a certificate, and a citation.
2. The award is presented every two years to an individual (academic/practitioner) for their significant contribution to the field of Victimology in India.
3. Members of the ISV can send nominations in writing, providing complete details of the achievement/contribution made by the nominee to the General Secretary of the ISV. Self-nominations will **NOT** be accepted.
4. The nominee for this award should not hold office or position in the management of the ISV during the period of nomination.
5. The General Secretary will place all nominations received (within the stipulated deadline) before the Awards Committee, constituted by the Executive Committee of the ISV.
6. The recommendations of the Awards Committee may be approved by the Executive Committee of the ISV. The decision of the Executive Committee will be **FINAL**.
7. The Awardee will be intimated of the decision of the Executive Committee of the ISV and he/she will be requested to receive the award during the inaugural function of the Biennial Conference of the ISV.
8. If the Awards Committee feels that there is none in its wisdom deserving of the award in a given year, the Committee has the right to decide accordingly.

(B) Fellowship Award

1. This award is given to individuals in recognition of their significant contribution to the growth and development of the ISV.
2. Members of the ISV can send nominations in writing, providing complete details of the achievement/contribution made by the nominee to the General Secretary of the ISV.
3. Self-nominations are **NOT** accepted.
4. The Executive Committee of the ISV will decide upon the Awardee(s).
5. The award will be signed by the President and General Secretary of the ISV.

Deadline for Nominations

The nominations for the Professor K. Chockalingam Award and the Fellowship Award should be emailed to the General Secretary at indiansocietyofvictimology@gmail.com on or before **20th September 2022**.

(C) ISV Best Research Paper Award

1. This award will be presented to a researcher below the age of 30 for his/her original research in the field of Victimology.
2. The research paper should be the outcome of an original empirical research on a subject of recent relevance in victimology and victim assistance.
3. A participant can only send one paper for consideration. For practical reasons, papers with joint authorship will not be permitted.
4. Papers should be in Times New Roman font, 12 point with double line spacing, leaving margin space on all sides. Name of the author should be provided on a separate page.
5. The author of the paper should submit a bonafide certificate from the institution where he/she is studying. The working author should also submit a Declaration that the research is an original piece of work done by him/her and does not form a part of a thesis/dissertation for the award of any degree/diploma or any other award or prize.
6. An Expert Committee will review and shortlist papers. The shortlisted contestants will have to present their paper during the ISV Best Research Paper Award Session before the Expert Committee, following which the winner will be decided and presented with the award.
7. The contestants of the ISV Best Research Paper Award should email their papers to the General Secretary at indiansocietyofvictimology@gmail.com on or before **20th September 2022**.
