JUDGMENT WRITING COMPETITION

School of Legal Studies and Governance, Career Point University Hamirpur (H.P) Organizing the Judgment Writing Competition, 2022.

The Judgment writing competition entails to capture the art of decision making in budding lawyers aspiring to join the reputed judicial services and to unfold the dynamic role of the Judges in relation to society.

The judgment writing competition involves a comprehensive approach towards law in terms of theory and implication of law. The legal arguments on facts and situation with legal precedents and reasoning pave way for judgment writing. This shall be an off line event.

Rules & Regulations

Guidelines and essential information for the Online Judgment Writing Competition-2022 are as under:

Eligiblity

- The submission is open to all Law Students registered in Graduate/Post Graduate Course in any Institution/ College/ University.
- The students can register single registration. ۲
- There is restriction on the number of entries from any college or university up to 2 only. ۲
- The participants shall write a single opinion. Multiple opinions/dissenting opinions are not allowed. ۲

Format Guideline

- Language-The language for writing the judgment shall be in English only.
- Participants may access wi-fi facility in library while writing judgments. They may bring and use their own laptops or any other reference material. Electricity connection for charging laptops may not be available. The judgment itself must be written by hand and completed in the Library Hall on sheets provided by college. Anyone found to have prepared judgment in advance will be disqualified from the competition.
- > Only single author is permitted.
- The Judgment Writing shall begin on the next page. The first page of Judgment must contain Team Code, Name of the Court, Title, Number of the Case, Date of Delivery of Judgment, Nature of the Case (Civil/Criminal/Writ).
 Do not state any matter in the judgment (except the cover page) that might reveal your identity or of your institution.

JUDGMENT WRITING COMPETITION, 2022 Proposition

DISCLAIMER: The facts stated in the present case are fictitious and have been drafted solely for the purposes of the competition. The facts, names, locations and dates bear no resemblance to any person, event or happening whether dead or alive. Any resemblance, if any found is purely co-incidental. No additional evidence or additional witness testimonies (other than provided) can be brought on record by any team for the purposes of the competition. Failure to adhere to the same will result in disqualification. The names used in the case are purely for the purposes of the competition. No real incidences are to be attached with them. This problem does not intend to hurt the feelings of any section of the society or to offend any person.

Soma, an eighteen year old girl was a student of 12th class. She belonged to a lower middle class family. Her father used to work as a clerk in a private firm. She had always been an ambitious and a very bright student. To support her father she used to give tuitions. Ramesh, Accused No.1, math's teacher of Soma in her school secretly developed emotions for her. Soma had always admired him as her teacher. On Soma,s 18th birthday Ramesh organised a birthday party for her at his house and gifted her an expensive watch. Unaware of Ramesh's feelings Soma accepted the same. On 14th Feb 2013, Ramesh proposed to Soma for marriage. Soma, however, told him to speak to her parents regarding the same. On 20th Feb Ramesh approached her parents with the proposal. However, they rejected his offer and warned him not to contact her anymore as they did not want that there should be any kind of distraction to their daughter as her XII boards were approaching. They strongly admonished Soma and threatened that they will discontinue her studies. Thereafter she started avoiding Ramesh. On one occasion Soma also made it clear to him that she will not go against the wishes of her parents and asked him not to follow her anymore. Despite the disinterest shown by Soma, Ramesh continued to follow Soma to her tuition classes and contacted her personally, on phone and through internet, believing that all her actions were under pressure from her parents. Soma reported the same to her parents. The parents rebuked him for his unwarranted acts. He, however, tried to convince them about his feelings for her and further stated that he wanted to marry her. They beat him and asked him to leave. Enraged with the feeling of dejection, Ramesh went to Mahesh in whom he always confided and narrated the whole thing. Mahesh, aged 45, has always supported Ramesh, who was residing with him, ever since his parents died in a road accident in 2000. Mahesh, who had always treated Ramesh as his son, could not bear the pain of Ramesh. Mahesh suggested to Ramesh that he should find Soma alone and take her to the temple for marrying her without information to her parents. In case Soma would offer any resistance due to parental pressure, Mahesh will threaten her with a bottle of acid to pressurise her to come with them to the temple. Mahesh also suggested to Ramesh to make nude pictures with the help of software, sharing of sexually explicit images and videos through the Instagram to Soma,s ID, Ramesh, who was initially reluctant, agreed to the plan on the condition that no harm will be caused to Soma and bottle of acid will only be used as a tool to threaten her for compliance to their wishes. On 22nd night Ramesh shared sexually explicit images and videos through the Instagram to Soma. On 23rd march, 2013 as per the plan, finding Soma passing on a lonely road, Ramesh and Mahesh, who were waiting for Soma, got out of the car. Ramesh approached Soma and asked her to accompany him to the temple so that they can get married. On Soma's refusal. Mahesh carrying the bottle of acid, threatened Soma, Ramesh started dragging her into the car. Soma started shouting loudly. To teach a lesson to Soma, Mahesh opened the bottle and threw the acid on her face and then both Mahesh and Ramesh fled away in the car belonging to and driven by Mahesh leaving the girl in immense pain. The girl was taken to the hospital by some passerby. The doctor immediately conducted the surgeries and opined that the injuries were grievous. FIR was lodged. Statement of Soma was recorded. A case was registered against both the accused under Sec 326A r/w Sec 34 IPC, 1860 and Ramesh was also charged under Sec 354D, IPC, 1860, Sec 66E, 67, 67A, 67B of IT Act 2000. Mahesh absconded and was declared a proclaimed offender while Ramesh was arrested by police from his home and the bottle of acid and car, used in the crime, were seized 49 from his possession. After investigation, he was put to trial before the Sessions Court, where he pleaded not guilty and claimed trial. Sessions Court convicted Ramesh under section 326A r/w section 34, of IPC, 1860, Sec 66E, 67, 67A, 67B of IT Act 2000 with rigorous imprisonment. He was also asked to pay compensation to Soma to the tune of Rs 2,00,000/- to be paid immediately. He was also awarded rigorous imprisonment for 2 years under Section 354D, IPC, 1860.

NATIONAL CLIENT COUNSELLING COPETITION

1. Team Composition

- Each team must consist of two participants only.
- The two participants may be from any of the 3 y ear or 5 y ear LLB course. Teams shall not be altered after registration.

2. Composition Format \backslash

- There shall be 1 Round of Counselling session in Preliminary Round. Two teams with highest score will be selected for the Final Counselling Session.
- There shall be 1 Round of Counselling Session in finals.
- Each Counselling Session is divided into three parts: Consultation, Post-Consultation and Critique

CONSULTATION :

- The consultation period shall be for 20 minutes in Preliminary Session.
- The consultation period shall be for 30 minutes in Final Session
- The time period will start from the moment the client enters the chamber.
- The time period is meant to be used for inter alia consultation with the client during which participants are expected to elicit the relevant information, outline the problem, find the clients expectations and propose a solution or other means of resolving the problem.
- During the consultation and post consultation, the team may use books, notes and other materials. The team may also use office props (Files, furnishings, bookshelves etc.) and any other material to furnish their consultation room or for other relevant purposes which is to be brought by the teams themselves.
- The time period is to be strictly adhered to but the judges may, in case of any reasonable circumstances provide a next one minute to the team after which the client would necessarily leave and the post-consultation period would begin.
- If the extended consultation session allowed an opportunity for a team to gather more information than other teams this circumstance should be taken into consideration by the judges in making their decision. Judges may, in their discretion, penalize teams that allow the interview session to run longer than the stipulated time period.

POST CONSULTATION :

- In the post consultation period the participants may talk to each other loudly so as to be audible to the judges or may indirectly address them in any other manner.
- Participants may summarize the interview, indicate the scope of the legal work to be undertaken, and state the legal issues that should be researched. Explanation of the position or attitude taken by the students may be useful.

- If the students feel that some documents are appropriate, like letter to the client confirming their retention as attorneys, the fee arrangement etc., or a letter to Opposing counsel or to the party with whom the client is having their legal problems etc., they may dictate such a document to the post consultation stage.
- The time period of post consultation is 5 Minutes.
- At the completion of time period of post consultation the judges shall stop the participants or signal them to stop in an obvious manner. Failure of the participants to comply with the above rule will attract negative marking as prescribed by the organizers to the judge.

CRITIQUE

- After the completion of the Post Consultation period the judges may question the participants on matters deliberated upon or mentioned by the participants or the client during the consultation or post consultation period.
- The judges may ask any question which they consider material and question meant to test the participants understanding of facts and law applicable or applied by the participants in the case.
- The time period for this session is 3 minutes and the judges may extend it by another two minutes at their discretion.

LAW APPLICABLE

The problems shall be broadly based on but not completely limited to following laws and participants are expected to have knowledge of any other ancillary laws and procedures

1. Family Law

2. Contracts

JUDGING CRITERIA (total 100 marks)

- Alternative Courses of Action (10 marks): Consistent with the analysis of clients problem, developed asset of potentially effective and feasible alternatives, legal and non legal.
- Clients goal and expectations (20 marks) :Learned the client's goals and initial expectations, modified or developed these as necessary.
- Moral and Ethical Issues(10 marks): recognized, Clarified and responded to any moral or ethical issues which may have arisen without being prejudicial in judgments.
- Post Interview Reflection(20 marks): During the follow up phase gave evidence of having recognized their own and clients feelings, strengths and limitations of their interviewing and counseling skills, their handling of substantive aspects of clients' problems, legal and non legal, provided for an effective follow up.
- Problem Analysis and Effective Conclusion (20 marks): Analysed the clients problem with creativity and from both legal and non legal perspectives resulting in clear and useful formulation of the problem.
- Team Work(20 marks): As collaborating counselors, worked together as a team, with flexibility and an appropriate balance of participation.

Cultural Events are open to Non law students also.


- Vulgarity and obscenity will not be entertained in any form.
