- All submissions shall be sent in **.doc/.docx** format only.
- Intimation for acceptance/improvisation will be provided within a week from the last date of the submission of the abstract.
- The length of the full paper including tables, diagrams, illustrations, references, etc. should be **3000-8000 words**.
- The paper should be typed in **Times New Roman, Font size 12 with 1.5 line spacing**.
- The footnotes must be typed in **Times New Roman, font size 10 with single spacing**. Format of Footnoting - **Bluebook 20th Edition/APA**
- The margin of 1 inch on all sides must be maintained throughout the paper.
- The prescribed footnoting format shall be **strictly followed** for footnoting. **Do not mention references**, only footnotes will be considered.
