National Client Counselling Competition 2023

Rules and Regulations

1. GENERAL

1.1. Composition of Team

Each time must comprise of Two (2) members. This number cannot be modified under any circumstances.

1.2. Eligibility

The competition is open for students pursuing 3 year or 5 year LL.B from any University approved by the Bar Council of India. No cross-university team shall be allowed to participate. Only one team per University may register.

1.3. Date and Venue

The Competition shall take place on 19 March 2023. The Competition will take place in physical mode at Hamdard Institute of Legal Studies & Research (HILSR), School of Law, Jamia Hamdard, New Delhi. However, kindly note that the competition may be held in online mode in case Covid-19 pandemic worsens.

1.4. Language

The language of the Competition shall only be English.

1.5. Dress Code

The dress code shall be White Shirt, Black Pant, Black Coat and Black shoes for Boys and White Shirt, Black Pant, Black Coat, Black shoes or White and Black Indian Formals along with Black Coat for Girls.

2.REGISTRATIONS

- 2.1. All interested teams must register themselves by filling the following form: https://forms.gle/XKNkNSE7UCqCrvAd6 .Teams must not forget to attach the proof of fee payment in the form.
- 2.2. At the time of registration, teams must attach a NOC from the University Head/Dean/Director. The same must be attached with the form.
- 2.3. The last date for registration shall be 18 February 2023.
- 2.4. The registration fee for the competition shall be Rs 2,000 per team. Teams must note that this amount will not be refunded.
- 2.5. Only 16 teams on first come first basis will be participating in the competition. Before making the payment, the teams must check if the google form is still accepting responses or not. The participants may contact any of the contact persons in case of any query in this regard.
- 2.6. The registration fee shall not be refunded under any circumstances.
- 2.7. The payment must be made via Online Bank Transfer to the following account:

- 2.8. After filling the form, the registered teams shall receive a team code, which shall be used for any further communication.

3. COMPETITION ROUNDS

The Competition shall comprise of Preliminary Round, Quarter Final Round, Semi Final Round and Final Round.

- 3.1. Top 8 teams will go to the quarter-final round on the basis of the team score of the preliminary round.
- 3.2. Top 4 teams will go to the semi-final round on the basis of the team score in quarter-final round.
- 3.3. Top two teams from the semi-final rounds will go to the final round on the basis of team scores.
- 3.4. Team with the highest score in the final round shall be declared as winner.
- 3.5. In case of tie between teams, all such teams shall proceed to the next round of the competition.

4. COMPETITION PROCEDURE

The Competition shall comprise of Preliminary Round, Quarter Final Round, Semi Final Round and Final Round. Client shall be of the host institute.

- 4.1. Each team shall go through a 30 minute session. First 5 minutes will be for setting up the room for clients, 20 minutes for client interview and 5 minutes for discussion with the judge.
- 4.2. During the post interview period of 10 minutes, the participants will have to summarize the interview, analyse the problem and indicate the course of action to be undertaken to the judge. The client shall not be present at this time.
- 4.3. During the period of 20 minutes, participants may refer to any books or laptop, which they may bring with them.
- 4.4. Teams shall not exceed the allotted time, except as otherwise permitted by the judges.
- 4.5. The problem for the Client Counselling will be based on any of these subject areas: Criminal law, family law, cyber law or any other relevant law as the organisers may deem fit.

- 3.2. One person from the team shall speak for the motion and the other shall speak against the motion.
- 3.3. Each team has to choose any one of the topics mentioned above. Each team will be given 10 minutes to speak on the said topic.
- 3.4. Each speaker from the team shall speak for 3 minutes minutes followed by 2 minutes of questions by the judges.
- 3.5. Team with the highest aggregate score shall be declared as the winner, team with the second highest aggregate score shall be declared as the first runner up, team with the third highest score shall be declared as the second runners up.
- 3.6. The student who obtains the highest score will be declared as the best student debater.

Rules and Regulations

1. GENERAL

1.1. Composition of Team

Each time may comprise of maximum ten (10) members. This number cannot be modified under any circumstances.

1.2. Eligibility

The competition is open for students pursuing 3 year or 5 year LL.B or LL.M from any University approved by the Bar Council of India. No cross-university team shall be allowed to participate. Only one team per University may register.

1.3. Date and Venue

The Competition shall take place on 17 March 2023. The Competition will take place in physical mode at Hamdard Institute of Legal Studies & Research (HILSR), School of Law, Jamia Hamdard, New Delhi. However, kindly note that the competition may be held in online mode in case Covid-19 pandemic worsens.

1.4. Language

The language of the Competition shall only be English or Hindi.

1.5. Dress Code

The dress code shall be Black Kurta with jeans along with red dupatta.

2. COMPETITION PROCEDURE
