	DETAILED GUIDELINES
•	An ' All India Entrance Examination ' shall be conducted by Rashtriya Raksha University (RRU) for various Master of Laws (LL.M.) programs offered by the following schools - School of Integrated Coastal and Maritime Security Studies (SICMSS) <i>LL.M. in Coastal and Maritime Security Law and Governance (CMSL&G)</i> School of National Security and Law (SNSL) <i>LL.M. in Criminal and Security Laws (CSL)</i>
•	The Entrance examination shall be common for both the above-listed programs. However, applicants desirous of applying to both LL.M. programs (i.e.) (CMSL&G) & (CSL) offered by SICMSS & SNSL respectively shall be required to apply separately for both the programs and pay the application fee separately. Merit lists for both programs shall be prepared separately by the respective school and will include only those applicants who have applied specifically for the given program/school and have appeared in the entrance examination.
•	For the present round of admission, marks secured in the entrance examination shall be the sole criteria to offer admission at RRU. CLAT Score shall NOT be the criteria to declare the merit list in this round.
•	The All India Entrance Examination by RRU shall be conducted through 'Online Proctored Mode' . This mode of exam will enable the applicant to appear for the exam from any location using their own Laptop/ Personal Computer. The exam session will be recorded and monitored, on real-time basis, by the RRU Staff to ensure that no unfair means is used and the sanctity of the exam is maintained. Any student, if found indulging in any unfair means during the course of examination, shall be debarred from the admission process and the university will be free to take action.
•	Applicant must have a Laptop/ Personal Computer with a webcam & mic which are in an operational state along with power backup to attend the online proctored exam.
•	Applicant should log in on the entrance examination portal at least 15 minutes in advance before the commencement of the examination.
•	The place from where an applicant wishes to give the examination should be neat and clear, with no writing visible on walls or surfaces, and the applicant must be alone in the room with no disturbance whatsoever.
•	The alignment of the web camera should be such that the full face of the applicant, without goggles or cap, be visible completely at all times during the exam.
•	The Technical requirements with respect to the laptop/personal computer, if any and other details along with the examination link shall be shared in due course of time, at least one day in advance from the date of the entrance exam, on the registered email address of the applicant.
•	It shall be the responsibility of the applicant to regularly check the registered email, both inbox & spam, for communication from the university and ensure that the communicated technical requirements are met before the examination and comply with the regulations set by the university from time

	to time.				
•	The Examination shall be of One-hour duration (60 Minutes) . The exact timing of the examination will be updated in the due course of time on the university website.				
•	The Question paper will be 100 marks having fifty Multiple Choice Questions (MCQs) of two marks each.				
•	There shall be no negative marking.				
•	 The question shall be general on the following subjects including landmark case studies and contemporary legal issues.
