About IIULER Entrance Exam - IIULET 2023

Entrance exam of IIULER, known as IIULET for both PG and UG courses is scheduled on **10th June**, **2023**, and the **last date of submitting registration form is 31st May**, **2023**.

The IIULET/ Registration fee for UG and PG courses has been reduced to Rs 1500 for General and to Rs 1000 for SC/ ST and physically disabled.

Scholarship Schemes in UG courses have been introduced for the meritorious but economically weaker students.

Special incentive schemes have been introduced in UG courses for State and UT toppers of IIULET.

THE DETAILED INFORMATION IS GIVEN BELOW:

REDUCTION IN REGISTRATION FEE/IIULET

The fee for General candidates who fill up IIULER registration form for 5 years LL.B integrated Honours degree and for LL.M or for any course is hereby reduced to Rs.1500/- from the present cost of Rs.4000/- in order to encourage more students to register and to also appear in IIULET exam.

The registration fee for SC/ST/disabled quota candidates with minimum 40 percent of relevant disability, with a certificate preferably from the Medical Board constituted by Centre or State, which shall be duly verified at appropriate stage, is hereby reduced to Rs.1000/-.

The extra fee taken from other students who have already registered and paid Rs.4000/-, shall be refunded after 31st May 2023.

MARVELLOUS SCHOLARSHIP SCHEME FOR UG STUDENTS:

Those candidates of LL.B 5 year Integrated Honours degree course who get 95% and above in IIULET shall be given relaxation upto 60% in Tuition fee and those who get 85% to 94% shall be given 50% relaxation in tuition fee and those who get 75 to 84 % shall be given 25 % relaxation in tuition fee for the academic year 2023-2024 i.e. in the first year *(Conditions Apply- For More Details - visit us at <u>www.iiuler.com</u>).*

"The same scholarship terms and conditions shall apply to all admitted students of LL.B 5 year integrated Honours Degree course, regardless of whether they obtain scholarship in IIULET, or not, for each academic year, on the basis of their average percentage as per the above scholarship scheme in the University exams of both semesters in the 1st year, for scholarship in the 2nd year, and for both semesters in 2nd year for scholarship in the 3rd year and for both semesters in the 3rd year for scholarship in the 4th year.Students in the 4th year", "who fall within the "scholarship" category for the 5th year, on the basis of their percentage in the 4th year will be eligible to keep their scholarship for the final year only, if they fall within the "scholarship criteria in their final year exams too.Their scholarship may "be" proportionately "reduced or even increased depending upon the average score of both 4th year and 5th year" exams."

SPECIAL INCENTIVE TO STATE AND UT TOPPER IN UG, IIULET

In order to encourage representation from all the States and Union Territories, a State topper and Union Territory topper at UG, IIULET, regardless of the general scholarship scheme, having scored a minimum of 70 percent in UG, IIULET, even if she/he has not qualified as per the scholarship scheme mentioned above, as an incentive and exception to the above scholarship scheme, shall be given 60 percent scholarship/rebate in tuition fee in the UG course for the academic year 2023-2024.

~Thereafter, the scholarship scheme as is generally applicable for all students will be applicable to her/him, to be eligible for scholarship in 2nd year and subsequent academic years, if she/he she falls within such category.~ ~~The special scholarship scheme for State and UT toppers of IIULET, provided they obtain a minimum of 70 percent in IIULET, is only for the academic year 2023-2024.~

This scholarship scheme is only for UG courses. *This scholarship scheme is subject to revision for the 2024-2025 batch of students.*~
