The authors are requested to submit manuscripts which incorporate an interdisciplinary approach. Manuscripts' research area may be from the following sub-areas including, but not limited to:

- Law and Sociology
- Law and Theology
- Law and Political Science

The articles to be submitted are not limited to the above mentioned themes.

Categories

- **Long Articles:** 6000-8000 words (excluding footnotes)
- **Short Articles:** 4000-6000 words (excluding footnotes)
- **Case Comments:** 1500-2500 words (excluding footnotes)

The journal is flexible on the word count depending on the quality of the submission.

Submission Procedure

The deadline for submission is **15th June, 2023**.

All submissions shall only be made to **slsreview@slnagpur.edu.in** with the subject: **SNLR Volume II Issue II (2023)** along with the type of manuscript.

Submission Guidelines

- All submissions must be accompanied by an abstract of not more than 300 words and a minimum of 4 keywords.
- The contributions submitted for publication in the journal must neither have been previously published nor currently, be under consideration for publication elsewhere.
- Co-Authorship of one person other than the author is allowed.
- The manuscript's first page must contain only the name of the author(s) and his/her institutional affiliation, professional information, contact details including email and phone number, type of manuscript, and any other relevant information.
- All submissions must be sent in .doc or .docx format.
- All manuscripts should include an Introduction and Conclusion.
- Case laws should be in Italics in the body of the manuscript.
- The body of the manuscript shall be in Times New Roman, font size 12 with 1.5 line spacing and justified alignment.
- Citations shall be in Times New Roman, font size 10, and justified alignment.
- Citations must strictly conform to the standards laid down in The Bluebook 20th Edition.
- Speaking or substantive footnotes are highly discouraged.
- All hyperlinks must be in black colour and must not be underlined.
- Needless to say, plagiarized work will be rejected. Similarity only up to 10% will be accepted. Submissions should not have any AI-generated content.
- All submissions are to be sent to slsreview@slnagpur.edu.in with the subject: **SNLR Volume II Issue II (2023)** along with the type of manuscript.

Publication Policy

- All the submissions shall be put to a preliminary screening wherein a plagiarism check including AI-detected content will be conducted.
- Only those submissions which conform to the plagiarism guidelines will be put into a double-stage blind review process.
- The submissions will be reviewed and edited by the Editorial Board under the supervision of the Chief Editor.
- Authors will be required to make changes to the submissions as required by the Editorial Board before their acceptance.
- Only on the recommendations of the reviewers, the papers submitted shall be considered for publication.
- On average, it takes 3-4 weeks to review and revert with comments on the submissions. However, the same may exceed depending on the volume of submissions.
- There is no publication fee.
