I. ABOUT THE JOURNAL:

The JILSR is a double-blind peer reviewed, annual, double-blind, peer reviewed open access Journal run by the Department of International Law and Organisation, The Tamil Nadu Dr.

Ambedkar Law University, Chennai, Tamil Nadu, India.

This Journal provides an opportunity to the legal fraternity to positively contribute towards the international legal scholarship, particularly we encourage value-based contribution from the academia and students for the progressive development of international law and achieving harmonious living of all life forms. We seek to publish papers involving original, critical analysis, value based, human centric, revivalist and solution oriented international legal writing which significantly add knowledge enrichment for the benefit of students and future scholars.

II. ELIGIBILITY:

We emphasis on quality contribution from Judges, lawyers, academicians, research scholars, students, and others. Individual possessing academic interest cum background can also contribute.

III. SUBMISSION CATEGORIES:

Authors are requested to strictly adhere to the given **maximum word limit**. Word count is exclusive of footnotes:

**Articles**: 4000 words

**Notes and Comments:** 2500-3500 words

Case Law Review: 1500-2500 words

Book Review: 1500-2500 words

**Note:** Abstract shall not exceed 300 words. Minimum of Five Keywords must be mentioned.

#### IV. CITATION:

- 1. The footnotes must adhere to the standards of the Oxford University Standard for Citation of Legal Authorities (4th ed., 2012) (OSCOLA 4th edition).
- 2. The authors are discouraged from using speaking or substantive footnotes.
- 3. Use of endnotes or hyperlinks would not be accepted.

### V. SUBMISSION GUIDELINES:

- 1. The submissions of the manuscript shall be made to the specified email ID alone.
- 2. Submission made through any other mode will not be accepted.
- 3. Co-authorship is allowed only up to a maximum of 2 authors.
- 4. Each author is allowed to submit one submission only.
- 5. The manuscript must be submitted on before 23:59 hours on **June 31, 2023.**
- 6. The submitted document must include an *abstract* of above 300 words in the beginning, highlighting the structure and the essence of the manuscript. The abstract is exclusive of the word limit of the manuscript
- 7. Cross-University registration is permitted.
- 8. The authors shall be required to submit a **separate title cover** including the title of the paper, category of submission, author's name, designation, name of the institution, postal address, author's contact details such as email and contact number.
- 9. No fees need to be paid at any stage of publication.

#### VI. FORMATTING GUIDELINES:

- 1. All submissions shall be made in .doc/.docx format only. PDF submissions are not accepted.
- 2. The submission of the manuscript should be in the following format:

Title [Times New Roman, 12 points, 1.5 line spacing, Bold, All Caps, Centre Aligned] Main Body [Times New Roman, 12 points, 1.5 line spacing, Justified, 1-inch margin on all sides]

Footnotes [Times New Roman, 10 points, 1.0 line spacing, Justified]

Abstract [Times New Roman, 12 points, 1.5 line spacing, Italics, Justified Aligned]

Spellings should follow the British system of spelling. Word-endings -ise and -isation are preferred over -ize and -ization.

# VII. EVALUATION STAGE AND PARAMETERS

#### A. Plagiarism Review

1. The submission must be the original work of the author(s) and must be free from grammatical and spelling errors.

- 2. The author shall ensure the submission is not published previously or being currently under review in any other Journal/Conference/Book.
- 3. The author shall be required to submit a declaration of originality and non-submission to other journals and testify that there is no copy right infringement of whatsoever. The University and the Board will not be held responsible for the violations by the author who is solely responsible for his/her acts or omissions.
- 4. The submission shall be subjected to plagiarism check in Urkund software. Submission exceeding plagiarism of **20%** (**Twenty**) shall be rejected at this stage. A rejection mail shall be sent to the corresponding author.
- 5. The final decision of acceptance and publication of the manuscript rests with the Executive Editors.
- 6. Submissions are required to have proper citation of authorities. Any manuscript received without footnotes shall be outrightly rejected without a review. Paraphrasing without appropriate citation of authorities shall also qualify as plagiarism.
- 7. Secondary plagiarism, or plagiarism of the authorities cited may also be a ground for rejection of the manuscript.

### **B.** Content Review

In Content Review, the following parameters will be checked:

- 1. **Grammar and Language**: The language of the submission must be easy to understand. It should use concise sentencing. Author(s) are encouraged to maintain a uniform voice throughout the article. Rhetoric is discouraged.
- 2. **Structural and Logical Coherency:** The arguments advanced by the Author(s) must be logically sound. The Author(s) should introduce, contextualise, and conclude the arguments effectively. A clear structure of the manuscript should be maintained.
- 3. **Contemporary Relevance:** The subject-matter of the manuscript should be one that relates to recent developments, or lacunae in the topic addressed. The Author(s) are encouraged to contextualise their ideas, and emphasise on the importance of the topic addressed in the manuscript.
- 4. **Contribution to Existing Literature:** The manuscript must be one that positively contributes to the discipline. Over-referencing, or reiterating arguments already made on the particular topic should be avoided.
- 5. **Research and Referencing:** The authorities relied on must be authoritative, and be appropriate for the purpose they are being cited for. The citation standard prescribed by the Journal (OSCOLA 4th edition) must be strictly adhered to.

**C. Peer Review:** In Peer Review, the above parameters will be checked by experts in the field.
