Author(s) name(s), University/ Organization, Paper title, Email, Correspondence address and Mobile number to be stated clearly on the cover page of the letter.

No part of the paper should have been published earlier nor should it be under consideration for publication. Any form of plagiarism will result in immediate disqualification.

Author(s) will be required to fill the online registration form after selection of their abstract. One person may submit a maximum of only 1 article.
