# SAMADHAN

The Delhi High Court Mediation and Conciliation Centre, known as Samadhan, were established in May 2006. It results from the joint initiative of the Bench and the Bar of the Delhi High Court, who have committed themselves to Mediation as an appropriate method of Alternate Dispute Resolution. It is run by the Bar and is coordinated by an Organising Secretary. A panel of judges and advocates oversee the work of this Centre.



The Centre handles cases referred to it by the Delhi High Court, its subordinate courts, and the Supreme Court of India. The Centre has handled a variety of cases covering matters relating to business contracts/transactions, real estate and construction, consumer issues, employment and service issues, industrial disputes, banking and insurance cases, trademark and copyright disputes, accident-related claims, landlord-tenant disputes, partnership disputes, family and matrimonial disputes, child custody and visitation rights, verification in habeas corpus matters etc.

## OVERVIEW OF THE MEDIATION TRAINING PROGRAM

The Clinics Committee, School of Law, Bennett University is organising a 5 Day Mediation Training Program from 21st -23rd July 2023 & 28th -29th July 2023 in Collaboration with Samadhan(Delhi High Court Mediation and Conciliation Centre).

Mediation provides a substitute to the conventional methods of resolving disputes. It offers to resolve various types of matters including civil, commercial, industrial, and family etc., where litigation takes years to settle the disputes. It is a method which enables individuals and groups to maintain co-operation, social order and provides opportunity to reduce hostility. The training Program aims to enable participants to acquire comprehensive understanding of Mediation keeping in view the requirements of Section 89 of Civil Procedure Code, 1908 and other statutory enactments requiring use of mediation as an effective tool for dispute resolution.

The Mediation Training Program aims to equip participants with the knowledge, skills, and tools necessary to become effective mediators. The program provides a comprehensive understanding of mediation principles, facilitates the development of essential mediation skills, and prepares participants to facilitate the mediation process in various contexts. The trainers from Samadhan will provide training to the participants by using different methodologies like role play, group discussion, and problem-based learning.

- Develop a comprehensive understanding of mediation
- Enhance communication and conflict resolution skills
- Foster neutrality and impartiality.
- Acquire mediation techniques and strategies
- Build empathy and understanding
- Develop problem-solving and decision-making skills

- Understand ethical guidelines and professional standards
- Enhance self-awareness and reflective practice
- Promote the value of mediation

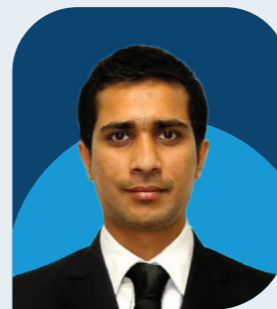

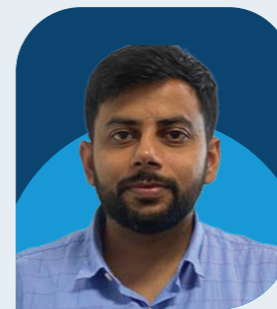
