The Indian Society of International Law (ISIL) and the International Committee of the Red Cross (ICRC) are happy to announce that the 22nd Henry Dunant Memorial Moot Court Competition on International Humanitarian Law will be held physical mode from 21st to 24th September 2023.

We cordially invite your esteemed institution to participate in the above event by sending a team of **three students** and a coach/teacher.

The aim of the 2023 Henry Dunant Memorial Moot Court Competition remains to promote awareness and understanding of International Humanitarian Law (IHL) among the law students and law faculties in India. This Moot Court Competition has been providing over the years an ample opportunity for the law students of this country to get a better understanding of IHL through contact with theorists and practitioners, and to become acquainted with the practical application and enforcement of this important area of law. The problem prepared for the Moot Court is normally based on contemporary issues of, and challenges to IHL. Participation in the Moot Court involves thorough research and detailed study of IHL treaties, including the 1949 Geneva Conventions and their 1977 Additional Protocols, and the rules of customary law applicable to this area.

The moot problem, registration form and the detailed rules and guidelines for the Moot Court Competition are enclosed. It is also available at ISIL website isil-aca.org. Registration form should reach us either by post (at ISIL) or by email (info.isil@gmail.com) as soon as possible.

The memorials and counter memorials (online) shall be submitted on or before 18th September 2023 at ISIL address. More details will be provided for conduct of competition after submission of memorials.

The organising committee will provide details of stay arrangement of the participating teams for the duration of the competition.
