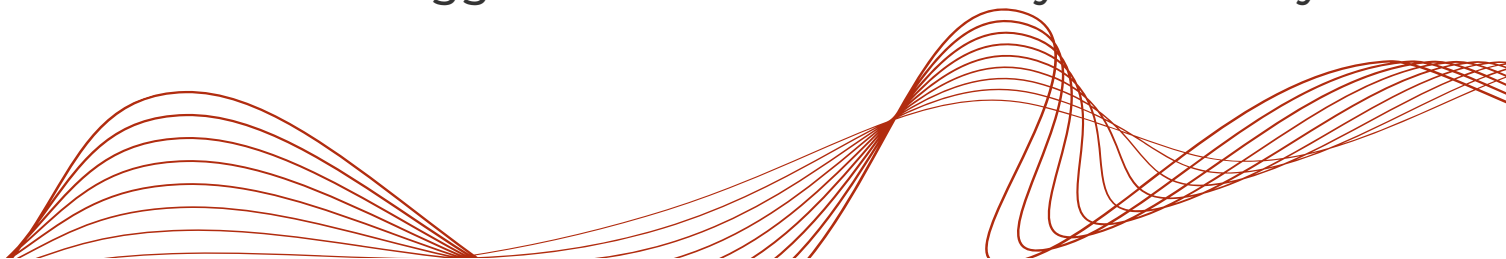

About the Event
