- References should be written in APA style (7th Ed.).
- Any type of Plagiarism in the chapter/ paper is strictly prohibited. Authors are advised to submit their papers/ articles after checking the plagiarism of the same, using online anti-plagiarism tools. The chapter/ paper with more than 10% of the plagiarism will not be accepted.
