#### **SUBMISSION GUIDELINES**

## General

-The CADR Editorial Board has a strict double-blind peer review process. For an understanding of the process, we encourage listening to this podcast<u>here</u>.

-At the outset, the authors are requested to send manuscripts that are original and unpublished. In case plagiarism is detected, the Editorial Board has the right to reject the submission. Due credit must be given, to the best of the authors' abilities, to all who have ideated the content the authors have submitted.

-All submissions must be accompanied by an abstract of preferably 150–250 words, and at no time more than 250 words, briefly explaining the crux of the submission/the research question/focus of commentary or analysis and if possible, the structure of the submission.

-Co-authorship is limited to a maximum of two authors.

## **SUBMISSION GUIDELINES**

Formatting

-All submissions must be in Times New Roman or Garamond, with a font size of 12, and a Spacing of 1.5.

-The citation style is Bluebook (21st edition)

# Submission Category

-3,000-5,000 words for short articles

-5,000-10,000 words for long articles

-1,500-3,000 words for case comments

The world limit is exclusive of footnotes.

Copyright

On submission, authors shall be deemed to have divested the copyright to CADR. However, all moral rights shall vest with the author(s)

## **Submission Procedure**

-The manuscripts shall be submitted through this <u>Google Form</u> only.

-Submissions made through any other mode will not be entertained.

-Each author is allowed to submit a maximum of 1 manuscript.

-Manuscript is to be submitted in .doc or .docx format
