Complex nuances emerge when evaluating the interplay between human rights, state interests, democratic principles, individual freedoms, and the digital age. Equally imperative are the roles and responsibilities of non-state actors, especially technology companies, in shaping AI's design and applications.

Guidelines for Submission of Final Paper

- Abstract (Minimum 300 words) along with 5 Minimum Keywords should be sent to iilmlawschool@iilm.edu
- The title of the paper should be followed by Name, Designation, Name of the Organization / University / Institution and Email address. It is mandatory to mention your Email address, as all future correspondence will be through it;
- Name and details of Co-author, if any;
- Chapter: The chapter should be in Times New Roman 12-point font and double-spaced. The main Title should be in full capitals, bold and centered with a 12-point font. Sub-titles should be in sentence case, bold and 12-point font. Author's names should be in small capitals and centered 12 point font Footnotes should be in Times New Roman 12-point font;
- Citation Format: Please use footnotes rather than endnotes. Footnotes should conform to INDIAN LAW INSTITUTE, NEW DELHI STYLE.
- The originality of Manuscripts: All the contributions should be the original work of the contributors and should not have been submitted for consideration in any other Publication. Any plagiarized work will be out-rightly rejected. (According to UGC Guidelines).

- Text Style (Times New Roman, Font 12, Line Spacing 1.5)
- Citation Style (The Indian Law Institute, New Delhi Citation), Times New Roman, Font 10, Line Spacing 1.0)
- The title of the Chapter should be followed by Name, Designation, Name of the Organization / University / Institution and Email address. It is mandatory to mention your Email address, as all future correspondence will be through it;
- Name and details of Co-author, if any;
- The paper should be typed in MS WORD format
- The paper must be in single column layout with margins justified on both sides;
- The length of the paper Should not exceed more than 5,000 (Including Footnotes);
- All Contributions must be submitted to iilmlawschool@iilm.edu.

Guidelines for Extended Abstracts

Although Abstracts are expected to take a global approach to the issues they cover, global south or country-specific case studies that relate to the AI and human right discourse will also be considered. Contributions adopting multidisciplinary approaches are also highly encouraged. Abstracts should set out a description of the topic to be addressed and the issues to be explored and the methodological approach taken. Abstracts should be between 300-500 words to be submitted, before or by November 12, 2023. Foreign delegates and those in remote locations will have the option of presenting remotely through online mode.

Publication Opportunity

Extended Abstracts will be published as a part of conference proceedings. Select papers may be published in an edited book by a reputed publisher. Once extended abstracts are accepted, the last date to submit final papers will be December 28, 2023.

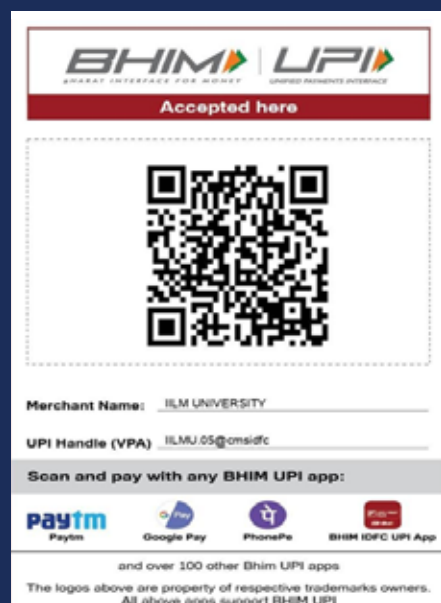
