**<u>1. ADMINISTRATION AND GENERAL RULES</u>** The name of the Competition is ORIENTAL COLLEGE OF LAW Presents VAKALAT : INTER COLLEGE MOOT COURT COMPETITION 2023

### 2. IMPLEMENTATION AND INTERPRETATION OF THE RULES

Rules and Procedures contained in this document shall apply to all participating teams. Regarding the practice and procedure of the Competition, the final interpretation in case of any conflict lies with the Moot Court Association ("MCA"). The decision of the MCA shall be final and binding on all. The rules of the Moot Court shall be strictly adhered to. Any deviation therein would attract disqualification or other penalties as decided by the Organizers.

### <u>3. ELIGIBILITY:</u>

1. Students pursuing their bachelor's degree in the current calendar year in a three-year or five-year course in law from any recognized school/ college/ university are eligible to participate in the competition.

2. The first 20 teams will be allowed to participate on first-come-first-serve basis.

3. Team members must be bonafide students of the University they are representing. Once registered (Final registration), a team will not be permitted to vary their composition in any manner.

### 4. OFFICIAL LANGUAGE:

The official language for the Competition shall be English, Hindi and Marathi only as per the rules of trial courts.

### 5. DATE AND VENUE OF THE COMPETITION:

Date: 26th to 28th October, 2023. Venue: The Oriental College of Law, Plot No 3, 4, 5, Sector 2, Sanpada, Navi Mumbai, Maharashtra 400705

### 6. TEAM COMPOSITION:

 The participating team shall comprise of :-MINIMUM THREE (3) - MAXIMUM FOUR (4) MEMBERS.
 In a team two (2) members under compulsion shall be designated as 'SPEAKERS', the remainder members shall have the liberty to enact/ represent themselves as the Prosecution witnesses.

3. The remainder members other than the speakers representing as witnesses may have the liberty to perform in any formation (i.e. one member may do all roles of witness or may split up amicably as per their convenience.) \*Note- SPEAKERS SHALL NOT BE WITNESSES 4. Once registered, a team will not be permitted to vary the composition of the team in any manner. Changes, if any, may only be made with the express permission of the MCA.

5. No additional/observer member shall be entitled to hospitality or certificate.


6. The Organizing Committee reserves the Right to bar any team from participating in the Competition

## 7. REGISTRATION PROCESS:

 Each institution must, first, provisionally register itself for the Competition by sending a mail with the registration form attached herewith. Once the confirmation is approved they can proceed further for the payment and online registration
 The Online Registration link will be shared alongwith the approval mail 3. Participants will receive an acknowledgement-cumapproval as a confirmation of their registration.

# 4. Teams are required to complete their Registration by 20th October, 2023 by 23:59 IST.

5. The Registration Fee is Rs.2000/- which shall be payable through Online Transition Mode (Non-Refundable) and shall be made in favor of the Oriental College of Law.
6. Stay shall be provided free of cost for outstation students only (outside Mumbai and Navi-Mumbai) Payment Details:



a) Bearing Subject as "PARTICIPATING TEAM'S COLLEGE NAME" e.g. (Subject: Oriental College of law, Sanpada) followed by Approval of their Moot Court Faculty Coordinator/Dean/Principle with the details of the participating team along with screenshot of fee receipt.

b) The Registration shall be deemed complete only when the Online Registration form is duly filled, Email Approval is received and the Registration fee is paid. The teams must send the Screenshot of their Online Transaction Fee through email to email id oclmootcourt@gmail.com and the teams shall receive the confirmation of their provisional Registration from Oriental College of Law Moot Court Association within 2–3 days.

### IDENTIFICATION OF PARTICIPATING TEAM

The Team Codes will be given on 23th Day of October, 2023. Each team will have a team code.

Disclosure of identity of the parent college/institution/university shall be made only in the registration form. Disclosure at any other point of time during the competition shall be liable for penalty which includes disqualification.

## 8. DRESS CODE:

1. Female participants are required to wear either a full suit comprising of a black formal blazer and trousers, full sleeved white shirts or white kurta, black bottom wear along with black blazer/over coat with formal foot wear.

2. Male participants are required to wear a full suit comprising of a black formal blazer and trousers, full sleeved white shirts, any color tie and formal foot wear.

3. Participating teams not following the dress code shall be disqualified.

### 9. RULES REGARDING MOOT MEMORIAL:

No Moot Memorial is required for the competition. A) TRIAL COURT GUIDELINES:

. Teams are required to prepare their cases respectively from each side i.e. from the side of Accused and from the side of Respondent as well.

.Teams shall have to make appropriate applications throughout the trial as and when required. Eg. Pursis or any other application supporting your case as per the Courts format

B) FORMAT OF APPLICATION

Teams shall get application as prescribed as per the Courts format by way of print or hand written at the time of the trial or in advance printed format, liberty is given to the teams as per their case and convenience. (Refer Exhibit 4)

C) CASE LAWS

Teams referring to any case laws during the trial shall produce one copy to the Judge and one copy to the other party with ratios marked

D) Teams being for the defence need to submit a <u>Vakalatnama</u>

E) Teams are required to adhere to the ACTUAL COURT ETTIQUETTES & PRACTISE/ CONDUCT. No contempt shall be tolerated.

### \*PRELIMINARY ROUND

In the Preliminary Round, the teams shall be given the opportunity to argue from both the sides (Round 1 and Round 2)

Brief Intro of case: 2 mins each team Examination in chief: 8 mins each Witness Cross Examination: 12 mins each Witness Final Argument: 15 mins for each team

The teams shall be chosen on the basis of their accumulated score in Round 1 and Round 2. On the basis of score, eight teams shall be selected for Semi Finals Round.

### \*SEMI FINAL ROUND:

In the Semi Finals the decision shall be on the basis on 'knockout' (The team shall be given the opportunity to argue from one side as per the draw of lots)

Brief Intro of case: 2 mins each team Examination in chief: 8 mins each Witness Cross Examination: 12 mins each Witness Final Argument: 15 mins for each team

On the basis of score, two teams shall be selected for Final Round.

### \*FINAL ROUND:

Each team shall be allotted Prosecution and Defense as per the draw of lots

Brief Intro of case: 5 mins each team Examination in chief: 10 mins each Witness Cross Examination: 15 mins each Witness Final Argument: 20 mins for each team

- Result of laboratory analysis: Detected Ganja from the seized articles P1,P2, SP1& SP2
- Brief facts of the case:

During refreshment being enjoyed by the complainant, the complainant came across Accused no.1. The said person had a small packet of ganja in his pocket, which fell downwhen he was heading towards the wash basin of Café Gulzar. Upon this the accused no.1 fled and the complainant began to follow him. Upon reaching at the crime spot the complainant informed PI Jadhav of the same. Upon the arrival of the PI a raid was conducted in 101 Dosa House in the presence of the PanchaShri Manish Pawar and seized nearly 10.2kg (10kg &200gms) of ganja each wrapped in a polythene bag from 2 jute bags respectively. Subsequent to which FIR came to be registered with Sewree Police Station.

• Chargesheet:

The Hon'ble Sessions Court of Gr. Mumbai within whose jurisdiction the present crime has occurred is being presented with the following case.

Dated 04.03.21 at about 6.20pm the complainant was enjoying refreshments at café Gulzar, Mazgaon. The accused no. 1 was sitting on the opposite table of the complainant. While the accused was heading towards the basin his packet containing Ganja fell down. Owing to this the accused got scared, picked up the packet and fled on his bike MH-01-AA-2345. Complainant began to follow him, subsequent to the incident. The accused entered one Dosa House bldg. The

complainant monitored the movement and accordingly informed the PI Amit Jadhav. Upon the arrival of the PI a raid was conducted in 101 Dosa House in the presence of the Pancha Shri Manish Pawar, Accuse No. 1 Lakhan Singh and Raj Sahu and seized nearly 10.2kg (10kg &200gms) each ganja wrapped in a polythene bag from 2 jute bags respectively. Subsequent to which FIR came to be registered with Sewree Police Station. The bags of Ganja were seized from the house of the Accused No.1, while the accused No.2 Raj Sahu was present at the spot.

The accused no.1 is into drug trade and was informed by one Aneez to keep the bag in his house. The bag was handed over to the accused no. 1 by one unknown individual, who delivered the same in the morning at 4.00 am on 04.03.21. However Aneez, unknown person are absconding and they shall be chargesheeted separately in a separate CR for their role in this offence.

The accused no. 2 was seen in the house of the accused no. 1 and is believed to have conspired the whole crime with common intention.

Without causing any delay in trial the Ld. I.O. is filing the present chargsheet against Accused No. 1 Lakhan Singh and Accused No. 2 RajSahu u/s 20(b) (ii) (C), 23(c) of NDPS Act & 120b, 34 of IPC before This Hon'ble Court.

10. First Information Contents:

On 4<sup>st</sup> day of March, 2021 in the evening PSI Tukaram Patil age 50 years old, an adult, Indian, Inhabitant, bearing buckle no. 45321/1994 presently serving at Sewree Police Station, Sewree, Mumbai-11, as a Police sub Inspector, was in a restaurant named Café Gulzar for refreshments, near Rosary High School, Mazgaon. At about 6.20pm the complainant came across an individual wearing black bush shirt and blue jean. The said individual was on opposite table, while he heading towards the basin a packet of him fell down, coincidently his eyes met the complainant's eyes and no sooner he picked it up than heimmediately got out of the café and rode his bike bearing no MH-01-AA-2345. Seeing this, the complainant found something fishy and began to follow him. The same was informed to P.I. Jadhav of Sewree Police station by phone after monitoring the situation at Dosa house, where the individual entered. Upon arrival of P.I. Jadhav, the complainant along with the watchman and PI Jadhav entered the room on 1<sup>st</sup> floor (101) and conducted search, where ganja was recovered weighingall together at 20.4 kg (20kg &400gms) in the presence of the 2 accused Lakhan Sigh and Raj Sahu. Subsequent to which the following CR was registered.

#### **STATEMENT**


I, Mr. Tukaram Balaji Patil, age 50 years old, an adult, Indian, Inhabitant, bearing buckle no. 45321/1994 presently serving at Sewree Police Station, Sewree, Mumbai-11, as a Police sub Inspector.

On 4<sup>st</sup> day of March, 2021 in café Gulzar, next to the Rosary High School, I was sitting for refreshment. No sooner than I placed my order for tea, one individual possessing an athlete body, standing tall at 5.4ft, wearing a black bush shirt and blue jean, at about 6.20 pm in the evening came in Café Gulzar and sat on the table ahead of me. I was facing the only main entrance of thehotel; the individual was on the table in vertical tandem of my table, with his back facing me. Upon his arrival he got a phone call, the call lasted for a couple of minutes, the only thing which I could hear was "JiJi...Ji, finally at one juncture the individual said " ji ghaas hai ghar pe". The last sentence made me questionable ghass & ghar. While wondering the same, the individual got up to head towards the basin on our east side, when a transparent polythene pouch bag fell down from his pocket. Prima facie it appeared to be like tobacco, which he immediately picked it up. As his eyes met mine he swiftly washed his hands and left the premise. I quickly evaluated the incident and went behind him, as I reached out of the hotell saw him leaving on a black bike bearing no. MH-01-AA-2345. I immediately began to follow him on my bike. Following the individual I reached at a building named Dosa House CHS LTD, opposite to Mazgaon Dock Ship Yard Ltd., the individual rode his bike in the premise of the building. I stopped there to monitor further movements and alongside immediately called my senior Mr. Amit Jadhav, P.I. at the incident spot by way of phone call. Mr. Jadhav reached at the spot within 2 minutes. Upon his arrival we proceeded further, we were stopped by the watchman and were asked to make entry in the register placed on the table next to the lift; subsequently an entry was made at 6.41pm. We asked the watchman about the individual, who happened to be Mr. Lakhan Singh further took the watch man with us to his room, which was on 1<sup>st</sup> floor. As we rang the bell Lakhan came out and attended us, from the door we could see he was inside with another person. We imparted our intention to frisk Lakhan and also offered our search to him thrice, all the time he refused. Owing this in the presence of the watchman we frisked Lakhan and found nothing. Further we called the other individual ahead for search, offered him our search which he refused, finally upon searching the other individual we found nothing.

Post this we stepped in the house which was a 120 sqft room. Upon searching for a few minutes in the house, in a cabinet as tall as 4ft with brown glossy finish, on the right hand side of the door we found two big jute bag each had a polythene bag with a substance like Ganja. On having a closer look we found ganja, each parcel appeared to weigh somewhere about 8 -9kg. Immediately we made Sewree Police Station cognizant and registered a FIR against the two accused.

The above contents have been read before me in Marathi andmy known language which I understand to be true and correct to the best of my knowledge.

The articles were received to me along with a request letter to conduct forensic analysis of the said articles. The articles which I received were in a brown envelope bearing a seal followed with a few signs namely of the pancha, accused and the I.O. upon breaking the seal, inside the envelope I found 4 packets namely P1, P2, SP1 and SP2. Prima facie they appeared to be a narcotic substance THC and were found with dried flower, fruiting top, leaves and stem. Each of the parent packets weighed packets weighed 10.175kg (10kg & 175gms) prior test and each of the 4 packets. The potency test was done by using methods like gas chromatography and high performance liquid chromatography. Upon the test an evaluation conclusion was drawn that the Tetrahydrocannabinol (THC) was present with nearly quarter part of contaminants

Based on the analysis the present research was d rawn and post conclusion was sent to the I.O. for further proceedings. The seized articles were returned back to the police authority for further disposal.
