### About the Journal

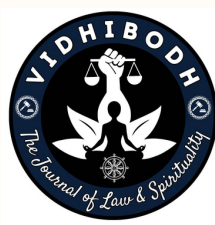

### Submission Categories

VIDHIBODH invites original, unpublished manuscripts in form of Articles, Case Notes, Legislative Comments, and Book Reviews.

### Word Limit

A contribution in the Journal should be between 1500 to 10000 words including abstract and footnotes. All contributions except book reviews should be accompanied by an abstract of not more than 200 words.

### Fee

There is no fee for publication and the Journal is an Open Access Journal.

### Submission Guidelines

- 1.A contribution may be authored by a single author or multiple authors.
- 2.All works must be original and unpublished. However, revised/reworked Articles might be considered subject to approval by the Editorial Board. The author/authors must inform the VIDHIBODH team if the contribution has been submitted elsewhere for publication.
- 3.Any form of plagiarism will result in immediate disqualification for publication.
- 4.The first page of the manuscript should contain the title of the paper, the name of the authors, and their institutional affiliation, followed by an abstract.
- 5.The main body of the manuscript should be in Times New Roman style, font size 12, with 1.5 line spacing and footnotes in Times New Roman Style, Size 10, with 1.0 line spacing. All headings must have uniform formatting.
- 6.All footnotes should conform to Rules of Footnoting followed by the Indian Law Institute.
