He took an LL.B. from the University of Latvia, before coming to the UK to take his M.Jur. (Dist, Clifford Chance Prize), M.Phil (Dist), and D.Phil. from the University of Oxford. He is a Member of the PhD Scientific Board of the Doctoral College of the University of Milan-Bicocca and a Global Fellow at the National University of Singapore Centre for International Law, and has held visiting positions at the National University of Singapore and the University of Bologna. He has received UCL Laws Excellence Award for Legal Teaching (EXALT): Graduate (2016) and was nominated for Student Choice Awards (2023).
