## SUBMISSION GUIDELINES/ FORMAT OF THE PAPERS

- a) The length of the paper must not be more than 5000 words (inclusive of footnotes and the title);
- b) The abstract must not exceed the word limit of 200 words; 5 keywords.
- c) Layout of the manuscripts:
- The body of the manuscript should be in Garamond/Times New Roman, Font Size 12, line spacing 1.5, Justified text;
  - The Sub Headings should be in Garamond/ Times New Roman, Font Size – 12, Bold, Justified text.
  - The footnotes should be in Garamond/Times New Roman, Font Size 10 and single line spacing;
  - The citation style should be in consonance in accordance with the “Blue book: A Uniform System of Citation (21st edition)”;
  - Speaking footnotes are discouraged;
- d) Layout for the Title and Abstract:
- Title: Garamond/Times New Roman, size-14, Bold, 1.5 line spacing, centre-aligned;
  - Abstract: Garamond/Times New Roman, size-12, italicized, 1.5 line spacing, justified text;
- e) There should not be any bullet points; pointers should be written as clauses and marked with either a, b, c or i, ii, iii and so on.
- f) All the submissions must be original and unpublished;
- g) A co-authorship of up to two people is allowed;
- h) The final decision as to the acceptance of manuscripts rests with the Editorial Board;
- i) Submission must be accompanied by a covering letter containing the information of the author(s) including the name, contact information (email id and contact number), name of their institution and their college/work identification;
- j) The authors would be required to submit an originality and copyright statement, dated and signed by the authors, during the submission of their papers, exclusively declaring that the submitted manuscripts are the original work of the authors;
- k) The authors would also be required to submit a statement, dated, and signed by the authors, agreeing that the copyright for their manuscript will vest with CLSG.

## REVIEW PROCESS

- The papers will be reviewed as per the following guidelines:
- Papers will be reviewed independently by at least two reviewers (professors and professionals) allotted on a random basis. It will be a blind peer review.
- The review will be based on grammar and language, structure and logical coherence, contemporary relevance, scientific rigor of the paper, originality and referencing of the research.

## REGISTRATION

- The registrations would be done on a first come-first-serve basis.
- A registration fee of **Rs. 1,000** would be charged from Single Authors.
- A registration fee of **Rs. 1,500** would be charged from Co-Authors.
