The Telecom Regulatory Authority of India (TRAI) was established with effect from 20th February 1997 by an Act of Parliament, called the Telecom Regulatory Authority of India Act, 1997, to regulate telecom and broadcasting sector including fixation/revision of tariffs, interconnection of network and lay down standards of quality of services to be provided by Service provider in telecom and broadcasting sector which were earlier vested with the Central Government.

One of the main objectives of TRAI is to provide a fair and transparent policy environment which promotes a level playing field and facilitates fair competition.
