## ABOUT THE WORKSHOP

There is visible lack of CLE in the State of Gujarat and the traditional universities teaching Law, do not have trained faculties or the necessary infrastructure to impart such a training, therefore, this CLE two days' training for teacher programmes in Gujarat can help to bridge the gap between legal education and the legal profession. The workshop emphasizes on the practical training aspect rather than focusing on just the theoretical aspects of CLE.
