ABOUT CCI

The objectives of the Act are sought to be achieved through the Competition Commission of India, which has been established by the Central Government with effect from 14th October 2003. CCI consists of a Chairperson and 6 Members appointed by the Central Government.

It is the duty of the Commission to eliminate practices having adverse effect on competition, promote and sustain competition, protect the interests of consumers and ensure freedom of trade in the markets of India. The Commission is also required to give opinion on competition issues on a reference received from a statutory authority established under any law and to undertake competition advocacy, create public awareness and impart training on competition issues.





ABOUT THE CONFERENCE

In an era defined by rapid technological advancements and digital transformation, the complexities surrounding competition law, technology, and intellectual property rights have reached unprecedented levels. In addition, IP and competition rules are increasingly significant in terms of joint ventures, mergers and acquisitions, cross licencing, patent pooling, and licencing in general in today's digitalization era.

This conference provides a platform for insightful discussions on how technology influences the landscape of competition law and intellectual property rights, and how legal frameworks are adapting to these changes. Attendees will engage in in-depth conversations about emerging challenges such as antitrust issues in the digital marketplace, the impact of artificial intelligence and data analytics on competition, and the evolving nature of intellectual property protection in the digital realm.

In addition, policymakers and enforcement agencies must be aware of the nexus between competition and IP law, particularly in light of emerging technical advancements like as machine learning, the IoT (Internet of Things), network technologies such as 4G and 5G, genetic engineering, and so on. Based on above background, this conference would cover the national and international issues and challenges by revisiting the synergies, tenets and practices followed under IPR, Technology and competition law.

FULL PAPER:

- 1. The length of full paper including tables, diagrams, illustrations, references, etc. shall not be less than 3000 words and shall not exceed 5000 words. (Excluding the footnotes).
- 2. Research paper shall be the original and unpublished work of the author. Co-authorship is permitted to maximum two authors. Each author is required to register and pay the registration fee individually.
- The paper should be typed in Times New Roman 12-point font with 1.5 line spacing.



- 4. All footnotes must be in Font "Times New Roman", font size 10, line spacing. All submissions must follow the "The Bluebook: A Uniform System of Citation (20th Edition).
- 5. The full paper should be submitted in soft copy (only after the acceptance of the abstract has been duly communicated) and shall be sent along with the registration fee screenshot on form:
