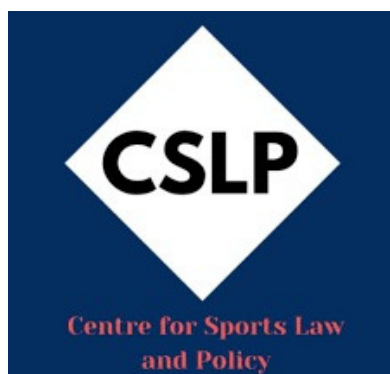
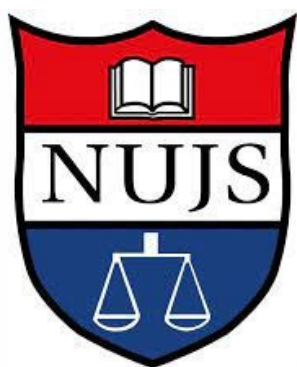

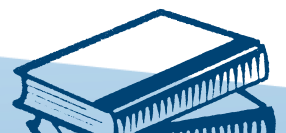
## ABOUT THE INTERNATIONAL CONFERENCE

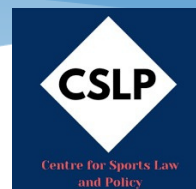


## ABSTRACT GUIDELINES:

- Abstract: 150 to 250 words with 5 to 6 keywords

## PLATFORM:

The paper presentations and seminars by the various panellists will be conducted via **Google Meet or Cisco Webex**. The links for the same will be shared via WhatsApp or email preceding the conference.

Participants will be given a **5-minute buffer time** in the case of network issues and/or will be allotted another time slot at the Organiser's discretion.

## PRESENTATION GUIDELINES:

The author/s will have to present their paper along with a **PowerPoint/Canva** (any other similar service) presentation that must be shared by them during the presentation.

Each author will have **15 minutes** to present their paper out of which 10 minutes will be used by them to present the paper and the remaining 5 minutes will be a question-and-answer and guiding session by the judges. The extension can be granted at the judging panels' discretion.
