- Visit the provided link below to access the registration form. Complete the form with precision, entering team details, participant names, contacts, and institution information. Ensure all required documents are uploaded accurately.
- Teams are suggested to choose a primary contact person. All the communications concerning the competition will be sent by email to the nominated contact person only. The nominated person shall be responsible to convey all the information to the team.
- The registration fee for the competition is set at INR 3,600 exclusive of accommodation, INR 6,000 with accommodation.
- Pay the competition fee via the designated bank account. Capture a screenshot of the payment confirmation for verification purposes. All participating institutions must confirm registration by attaching the payment receipt screenshot to the Google form by 05 february, 2024.
- Once registered, confirmation email acknowledging your successful registration. Information about team code that will be given to the teams.
- Stay updated with your email for competition updates, rule alterations, or any additional requirements.

TRAVEL, FOOD & ACCOMMODATION DETAILS

- Accommodation to all the qualifying teams shall be provided at hotels located near the university premises.
- Please note that separate accommodation will be provided for girls and boys.
- The teams may check-in to the hotels from March 1st, 2024.
- No Accommodation facility shall be provided post 1100 hours on March 3rd, 2024.
- The Organising Committee shall be responsible for providing transport to the qualifying teams to commute from the hotel to the Competition Venue and back.
- It is clarified that no drop-off facility shall be provided to the participants on their journey back after the competition's conclusion.
- All facilities shall be provided only to the registered members of a team and no additional members, parents, observers, coaches, or faculty advisors shall be accommodated.
- The qualifying teams for Quarter Final rounds must send their travel plans by February 25, 2024, through the Travel & Accommodation Form which will be circulated by the Organising Committee.
- Meals will be provided to the teams only on the following days:
 - March 2nd: Breakfast at the hotel, with lunch and dinner served on campus.
 - March 3rd: Breakfast at the hotel before checkout, followed by lunch provided on campus.
