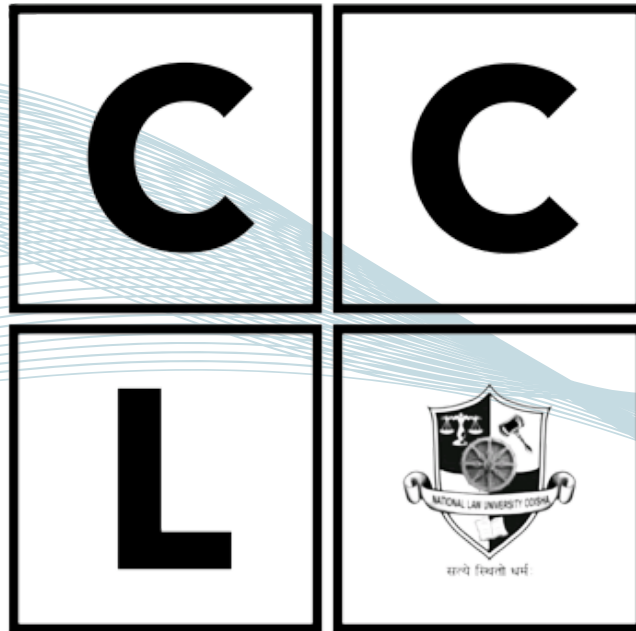

CCL BLOG

CCL Blog is a two tier peer-reviewed blog which aims to further the goal of increasing the quality of knowledge on nuanced areas of corporate law and increase the engagement and discussions on the present-day issues of contention. This would help bolster research within academia while simultaneously providing them with content abreast of updated information and analysis.

TWO TIER REVIEW POLICY

The Centre for Corporate law has adopted a unique 'Two Tier Review Policy' to create a platform that offers quality research & improve the existing literature on corporate and its allied commercial laws.

In the first stage of the review process, the submission will be checked by the Students Editors, for editorial compliance and plagiarism. Thereafter, in the Second Stage the submission will be reviewed by our editorial Board consisting of eminent editors which would include academicians as well as legal practitioners. Articles can be sent back to the author at any stage for incorporating suggested changes/complying with submission guidelines.

The decision by the Editorial Board (as the case may be) regarding acceptance or rejection of the Article will be final and binding.

SUBMISSION GUIDELINES

- Submissions should be the original work of the contributor and should not have been published or sent for publication elsewhere.
- Co-authorship is permitted up to 2 authors.
- We advise authors to hyperlink the sources for citation and prefer minimal use of footnotes (OSCOLA).
- Authors are advised to keep their articles concise and precise to enhance the effectiveness of their posts. The word limit should ideally range from 1300 – 1500 words (excluding footnotes).
- All submissions for the CCL Blog must be made via the Google Form linked at the end of the post. Any submission made via other platforms would be rejected.

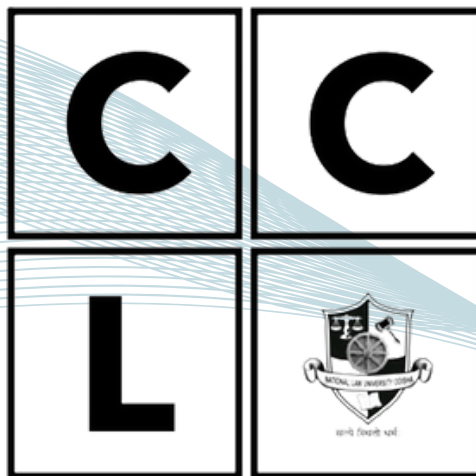

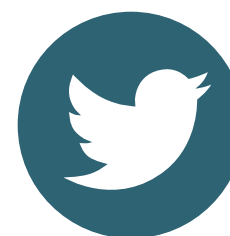
