SUBMISSION GUIDELINES :

- Abstract submissions must be strictly in Word format with a permissible co-authorship of maximum of 2 authors. However, registration has to be done individually.
- The abstract should be of 300 words including keywords. The abstract must be accompanied by following details - Name of the Author and Co-author (if any), Designation, Name of the Institution, email address and contact details of the authors.
- Full papers should be between 3000-4000 words (including footnotes) and should follow APA style of citation and referencing.

- The research paper should be sent in a Microsoft Word file.
- Font Style – Times New Roman, Font Size – 12, Line Spacing – 1.5, Margin on left side – 1.5 inch, Margin on right side – 1 inch.
- The cover page of manuscript must contain the title of the paper, Name of the Author and Co-author (if any), Designation, email address and contact details of the authors.
- The cover page should not be a part of paper so as to facilitate peer review of the paper.
- The participants should also attach plagiarism certificate assessed by authentic software.
- Selected papers will be published in a journal with ISSN number with 5+ impact factor.
