# REGISTRATION PROCESS

#### Step 1: Abstract Submission

The acceptance of papers will be contingent upon the abstracts provided. Each submitted abstract will undergo a blind review process. Authors are required to submit a succinct abstract, ranging between 300 to 400 words, distinctly encapsulating the arguments delineated in their paper, prior to the stipulated deadline. All abstracts must be submitted in English.

#### Step 2: Notification of Acceptance

The Centre will render its decision within a span of a few days subsequent to the submission of abstracts and duly inform the respective authors of the outcome.

#### {20-03-2024}

\*Upon receiving the acceptance mail, the participants are requested to register themselves. The abstracts will be reviewed and only shortlisted abstracts will be invited to submit final papers as well as to present them at the National Seminar.



# REGISTRATION PROCESS

#### **Step 3: Registration**

Upon the conclusive selection of the abstracts, authors and co-authors are mandated to complete the registration process. The registration form will be dispatched to the authors of the selected abstracts through email correspondence. The registration fee consists of expenses associated with participation in the seminar, and publication of selected papers during Praedium 2.0. **{26-03-2024}** 

#### Step 4: Payment of Registration Fees

Upon completion and submission of the registration form, participants are afforded the option to remit their registration fee via the College Bank Account only. It is imperative to note that registration fees apply to the authors whose abstracts have been selected.



# REGISTRATION PROCESS

#### **Registration Fee:**

1. For Students enrolled in undergraduate or post graduate programme (Indian): Single Author: Rs. 1000 Co-Author: Rs. 1600

2. For Professionals/Academicians/ Research Scholars/ Teachers:
Single Author: Rs. 1800 Online mode - Rs. 1500 Co-Author: Rs. 2200 Online mode - Rs. 2500

3. For Internal Students: Single author - Rs. 400 Co-Author - Rs. 600

#### **Step 5: Final Pap<mark>er Submission</mark>**

Academic papers, whose abstracts have been accepted and registered for the presentation in Praedium 2.0, should submit their final papers before the specified deadline. The same should be submitted along with the PPT that is to be presented, adhering to the guidelines delineated for paper submission. **{09-04-2024}** 



# REGISTRATION GUIDELINES

Interested candidates are requested to register themselves by providing the requisite details of the author(s) through the submission link provided on or before 26th March 2024. Coauthorship is allowed up to two members. Both the co-authors need to register for the seminar.

Registration link shall be provided via the notification of acceptance of the Abstract.

Kindly note that the payment of registration fees shall be exclusive of accommodation fees. Accommodation shall be provided as per team composition and the fee for the same shall be collected on 19th April 2024 (Offline).

Note: The regis<mark>tration fee will be non-refundable and non-transferable under any circumstances.</mark>

## SUBMISSION CATEGORIES

**1. Long Articles [Between 5000 and 8000 words]** Articles produced in this category are expected to strictly adhere to the theme. Fresh and novel ideas with a contemporary understanding of the topic are expected. For long articles, co-authors of up to two are permitted.

#### 2. Essays [Between 3000 and 5000 words]

Essays submitted in this category are expected to be concise and clear, well within the ambit of the chosen theme. Balanced arguments under the issue are expected in the essays. They should be easily identifiable, engaging, and thought-provoking. For essays, co-authors of up to two are permitted.



# SUBMISSION GUIDELINES

- Well researched and high-quality papers or case studies are invited from all sections of society for presentation at the Seminar.
- The final paper should be submitted only on the selection of the respective abstracts. The organisers reserve the right to accept or reject submissions based on relevancy, adherence to the theme, creativity, and contribution to existing literature.
- All manuscripts should be the original work of the author(s). The final decision for the selection of the manuscripts rests at the discretion of the Editorial Team.
- The name of the author(s) should not be indicated anywhere in the manuscript itself.



The following are the guidelines to be adhered to while submitting the manuscripts. Any non-compliance with the guidelines will attract deduction in marks.

- Formatting Style:
  - Text- Font: Times New Roman; Size: 12; Line Spacing: 1.5; Alignment: Justified.
  - Footnotes- Font: Times New Roman; Size: 10; Line Spacing: 1; Alignment: Justified.
- Citations: Author(s) are required to adhere to a uniform mode of citation; Bluebook 21st Edition
- Similarity Index: up to 10% subject to plagiarism check on Turnitin
- File Format: .doc and PDF form
- File Name: (Name of the Author) & (Name of the Co-Author)\_CRAT NATIONAL SEMINAR


