- Length of full paper: Not more than 3,500 words (excluding footnotes and title)
- Font and Font Size: Times New Roman, 12, Line spacing 1.5 and Alignment 'justify'
- Footnotes: Font 'Times New Roman', Font Size 10, line spacing 1.5
- Follow the Bluebook: A Uniform System of Citation (20th Edition) for footnoting.
- Submissions must be original and not yet published
- Co-authorship is allowed upto 2 authors excluding the main author
- In case there are multiple authors for the selected manuscripts, only one author would be allowed to present at the conference.
- Payment of Registration fees is mandatory for both presenters and the attendees

Review of papers: the reviewing of paper will be based on scientific rigour of the paper, originality of research, and its relevance to the conference themes. Notifications of acceptance will be sent out through mail by 22nd March 2024 on the basis of the review.

The high-quality papers may be published in selected peer reviewed journal
