SUBMISSION GUIDELINES

1. All manuscripts should be written in English.
2. Co-authorship is allowed but is limited to two.
3. The length of the abstract should not be more than 250-300 words.
4. Allowed plagiarism limit is 15 percent and beyond that would be rejected.
5. The main body of the manuscript should be in Times New Roman style, font size 12, with 1.5 line spacing and footnotes in Times New Roman Style, Size 10, with 1.0 line spacing.
6. The title of the manuscript should be in Times New Roman style, font size 18, with and heading size should be 16 and sub heading 14 .
7. The Citation Pattern should be as per Blue-book pattern or APA style.
8. All manuscripts should be sent as an attachment to the email nationalconferenceiul@gmail.com in .doc or docx format (such as Microsoft Word). We do not accept PDF submissions. Articles should be approximately 2500-4000 words in length.
9. Authors must ensure the accuracy of citations, quotations, diagrams, tables and maps.
10. Articles should be thoroughly checked and proofread before submission, both by the author. After you have submitted your article, you are unable to make any changes to it during the refereeing process, although if accepted, you will have a chance to make minor revisions after refereeing and before the final submission of your article.
