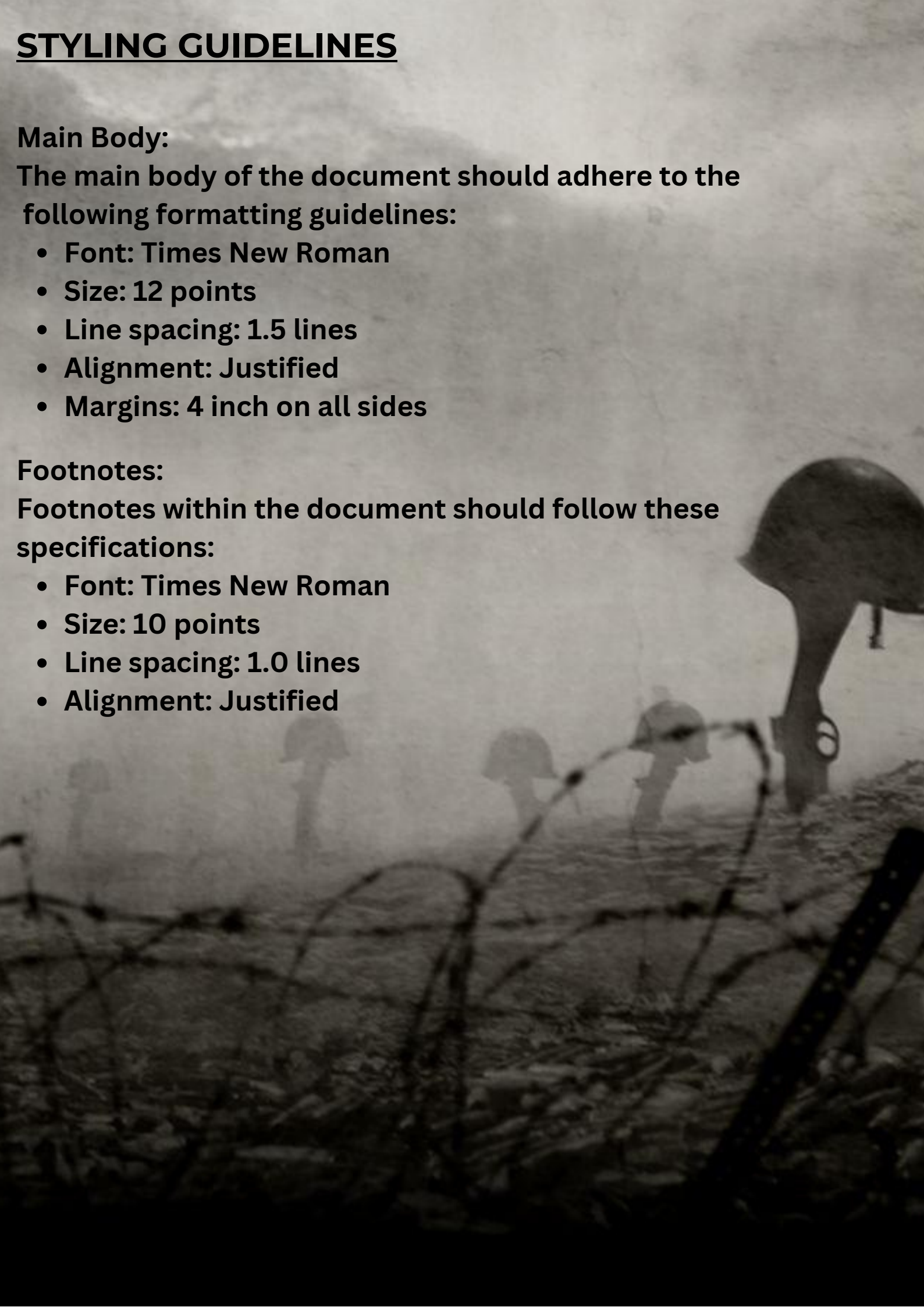
The main body of the document should adhere to the following formatting guidelines:

- **Font: Times New Roman**
- **Size: 10 points**
- **Line spacing: 1.0 lines**
- **Alignment: Justified**



Title:

The title of the document should be formatted as follows:

- **Font: Times New Roman**
- **Size: 14 points**
- **Line spacing: 1.5 lines**
- **Style: Bold, All Caps**
- **Alignment: Centre Aligned**

Heading Level 1:

For the primary headings, use the following formatting:

- **Font: Times New Roman**
- **Size: 14 points**
- **Line spacing: 1.5 lines**
- **Style: Bold, Sentence case, Capitalize each word in Small Caps**
- **Alignment: Centre Aligned**
- **Numbering: I, II, III, ...**

WORD LIMIT AND CITATION FORMAT

WORD LIMIT: The prescribed word limit for each submission is between 3000 to 5000 words.

Footnotes are excluded from this limit, and speaking footnotes are discouraged.

Citation Format: All citations must strictly adhere to the guidelines outlined in the Oxford University Standard for Citation of Legal Authorities (OSCOLA- 4th Edition) format.

Abstract Word Limit: Authors are required to provide a concise abstract summarizing their work within 300 to 350 words.

ADDITIONAL GUIDELINES:

- **The submissions should be original and not previously published or under consideration of being published.**
- **The organizers retain the discretion to accept or reject the submissions at any stage of the review process. The organizer's decision on the same shall be deemed final.**
- **Submissions should be accompanied with the personal details of author(s) including name, contact details, address for correspondence and institutional affiliation. These details must be submitted in a separate document along with the abstract.**
- **Selection of the paper will be based on a peer review process.**
- **Details of publication of the selected papers will be shared accordingly.**
- **A Best Paper Award will be given after peer- review based on the quality of research work.**
- **Participation certificate would be awarded based on the chosen mode of participation.**
- **Last date for submission of the abstract is 31st March, 2024.**
- **Last date for the submission of the research paper & Registration fees payment is 31st March, 2024.**
