SECOND NATIONAL ESSAY WRITING COMPETITION

The Second National Essay Writing Competition of the School of Law, SVKM's NMIMS, Indore, is open to all students studying from Class 10th to 12th, or any student enrolled in any undergraduate or postgraduate program under UGC. The competition aims to enhance research and writing skills while promoting creativity and originality among participants. All the essays will undergo an evaluation by the Research Cell Editorial Board of the college, and selected entries will have the opportunity to get their essays published.

THEME

The theme of the essay competition pertains to contemporary environmental challenges, necessitating a focused exploration of pertinent issues in the environmental domain.

RULES AND REGULATIONS

- The essays are to be submitted through mail at (pragyan.nmims@gmail.com) and the submissions made by any other means shall not be considered.
- All entries should be submitted in .doc or.docx format.
- The co-authorship of a maximum of two persons is permitted.
- Similarity and AI checks of the submissions will be done. A maximum of 10% of similarity is permissible
- The title shall be in Times New Roman, 14 points, 1.5 line spacing, bold, center aligned, and justified.
- The main body shall be Times New Roman, 12 points, 1.5 line spacing, justified, and 1-inch margins on all sides.
- The footnotes shall be in Times New Roman, 11 points, 1.0 line spacing, and justified.
- The word limit is 2500 – 3500 words.
- The citations shall be in Harvard's Bluebook Legal Citation System, 21st Edition.
- The essay shall be original, unpublished, and non-plagiarized and shall not be under simultaneous consideration for publication elsewhere.

FIRST NATIONAL LEGAL BLOG WRITING

The First National Legal Blog Writing Competition of the School of Law, SVKM's NMIMS, Indore, is open to all law students pursuing a bachelor's degree in law i.e. three-year LL.B./five-year LL.B. or a post-graduate course from any law school/university/college recognized by the Bar Council of India. The competition aims to enhance legal research and writing skills while promoting creativity and originality among participants. All the blogs will undergo an evaluation by the Research Cell Editorial Board of the college, and selected entries will have the opportunity to get their blogs published.

THEME

The designated theme for the legal blog writing competition centers on the examination of contemporary environmental legal matters, thereby inviting participants to delve into and analyze the current legal intricacies within the environmental realm.

RULES AND REGULATIONS

- The blogs are to be submitted through mail at (pragyan.nmims@gmail.com) and the submissions made by any other means shall not be considered.
- All entries should be submitted in .doc or.docx format.
- The co-authorship of a maximum of two persons is permitted.
- Similarity and AI checks of the submissions will be done. A maximum of 10% of similarity is permissible
- The title shall be in Times New Roman, 14 points, 1.5 line spacing, bold, center aligned, and justified.
- The main body shall be Times New Roman, 12 points, 1.5 line spacing, justified, and 1-inch margins on all sides.
- The footnotes shall be in Times New Roman, 11 points, 1.0 line spacing, and justified.
- The word limit is 1000 – 1500 words.
- The citations shall be in Harvard's Bluebook Legal Citation System, 21st Edition.
- The blogs shall be original, unpublished, and non-plagiarized and shall not be under simultaneous consideration for publication elsewhere.

Top performers will receive research internships under our knowledge partner Jus Corpus for one month in online mode. All members of each Team shall be awarded E-Certificates of Participation. Furthermore, the 5 finalists for the policy presentation round shall also be awarded E-Certificates of Merits.

REGISTRATION DETAILS

- All interested students shall be required to register for the competition in order to be eligible to participate in the same before 7th April, 2024(11:59 PM).
- The registration fee shall be non-refundable.
- The early bird registration fee is Rs. 300 per author till 31st March, 2024. Afterward, registration fee shall be Rs. 400 per author.
- The payment of the registration fee must be made according to the instructions provided in the registration form.

- Each team will be assigned a unique team code that they shall use as a reference point throughout the competition.
