- d. Foot Notes Please ensure that the footnotes are formatted correctly and consistently, in accordance with 20th Blue Book Edition with Times New Roman font size 10
- e. Pages to be numbered Bottom of the page, at the center numbered as 1, 2, 3, etc.
- f. Style for headings Chapter Title: All in caps, bold, centered.
- g. Style for subheadings

- h. The paper must be submitted in word document (.doc or .docx) format only.
- i. Research paper must highlight specific research problem/Issue and appropriate research methodology.
- j. Every research paper must contain the Abstract.
- k. Authors are requested to provide their brief profile with E-mail ID, contact number and affiliation at the end of the paper.
- 1. All submissions must be the author's original and unpublished work. Similarity Index should not exceed 15%.
