Its goal is to make law graduates more aware of the effectiveness of using persuasive facts and well-reasoned arguments. It allows them to explain their position by employing verbal elegance. It gives one a sense of composure and assurance. It teaches students how to conduct effective research, arrange information, and deliver it in an engaging way.

#### **THROWBACK**

Rajasthan School of Law for Women organized "Parley 3.0: National Debate Competition" on 5th and 6th June, 2023 in association with Rajasthan State Human Right Commission. As compared to last year's record the competition yet again has received remarkable level of responses from all over the country. As India promotes Unity in Diversity, continuing the legacy, Parley 3.0 National Debate Competition consisted of participants from four corners of India such as Rajasthan, Maharashtra, Hyderabad, Ranchi, Bengaluru, Punjab, Delhi, Bihar, Goa, Odisha, Madhya Pradesh, West Bengal, Karnataka, Jammu and Kashmir etc. 80 teams (160 participants) from pan India, participated in the competition. Students from prominent Law Colleges and Universities, like National Law University (Odisha), Maharashtra National Law University (Aurangabad, Nagpur), Amity University (Jaipur, Uttar Pradesh, Madhya Pradesh, Noida, Mumbai), Christ (Deemed to be University) (Delhi), Lloyd Law college (Greater Noida), Symbiosis Law college (Hyderabad), ICFAI University (Dehradun, Uttarakhand), Delhi University (Faculty of law), Allahabad University (Faculty of law), IFIM law school (Bengaluru), JNU (Jaipur), Calcutta University (Department of

- law), Central University of Kashmir participated in the competition.
- Parley 2.0: National Debate Competition was organized on 30th & 31st May 2022 where participation of more than 85 teams (170 participants) from all the prominent law institutes of the country was witnessed.
- Parley National Debate Competition 2021 was held on 6th February, 2021 which received a phenomenal level of response as 40 teams (80 participants) from all over India participated in the competition.

#### **RULES OF THE COMPETITION**

#### **Rule 1: ELIGIBILITY & TEAM COMPOSITION**

i. Members of the team must be valid Undergraduate students pursuing a recognized Bachelor of Law program. (Note – Bachelor of Law means a 3 year or 5 years integrated course in Law recognized by the Bar Council of India).
ii. The team shall comprise of two participants.
•Students from same College / University can participate as a team.
•Students from different Colleges / University can participate as a team.
iii. Only 3 teams per institute/ college / university are allowed to participate. (Selection on first come first basis)

#### **Rule 2: TOPICS OF THE COMPETITION**

- Preliminary (Round 1) 'Influence of Social Media on Election Campaign and Results'
- Semi-Final (Round 2) 'Censorship on Internet is Justified'
- Final (Round 3) 'Digital Privacy and Human Rights'

#### **Rule 3: STRUCTURE OF THE COMPETITION**

The Competition shall consist of three rounds a )The Preliminary Round; b )The Semi-Finals Round; and c )The Final Round

#### **1.Preliminary Round:**

- i. Competition will be conducted online through virtual rooms. Number of rooms depend on the number of entries received by the college for the competition.ii. Proportionally equal number of participants will qualify for semi-final round from each virtual room.
- iii. Each team shall consist of two speakers, one speaking for the motion and one against the motion which will be decided by the participants themselves.iv. Each Candidate will be allotted 3+1 minutes in Preliminary Round.v. There shall be no rebuttal in this round.

#### **2** .Semi-Final Round:

i. Selection for semi-final round will be on individual basis. It is not necessary that the entire team will qualify for this round.

ii. Only 16 participants will be selected.

iii. The motion will be given by the organizers to the participants after the declaration of result of preliminary round.

iv. Each Candidate will be allowed 3+1 minutes.

v. The motion would be decided by draw of lots.

vi. There would be no rebuttal in this round.

#### Note: Be prepared for both the motions in advance

#### **3.Final Round:**

i. Top 6 participants will qualify for final round.

ii. The motion would be given by the organizers after the declaration of results of semifinal round.

iii.Each Candidate will be allowed 5+1 minutes.

iv. The motion would be decided by draw of lots.

v. There would be rebuttal in this round.

Note: Be prepared for both the motions in advance.

#### **Rule 4: LANGUAGE**

The medium of communication shall be English only.

#### **Rule 5: DRESS CODE**

The dress code for the competition is western or Indian formals. Participants must adhere to the same.

#### **Rule 6: CRITERIA FOR EVALUATION**

The ground for evaluation of debate will be on following parameters: -

- Organization and Clarity
- Presentation Style
- Knowledge of Subject
- Originality and Ingeniousness
- Ability to deal with question and rebuttals concisely and effectively (only in final round).

#### **Rule 7: IMPORTANT DATES**

- Last Date for registration 10 May, 2024
- Date of Debate Competition 16th- 17th May, 2024

#### **Rule 8: REGISTRATION**

The teams will have to register themselves by filling the google form https://forms.gle/2h3yKM3BWfwSDyXi6

kindly complete and submit the registration form not later than May 10' 2024.

• The Composition of the team cannot be changed once a team has registered.

• Upon successful submission of Registration form, the teams will receive an email from the Organizers, providing them with their Team Code and informing them of their successful Registration.

• If teams do not receive such an email, it may contemporaneously send an email with its registration details to sociolegalrslw@gmail.com or directly contact the members of the organizing committee.

• The registration fee is non-transferable or non-refundable. Except in case of more then 3 entries from an institution, such amount will be refunded within one week of the completion of the debate.

#### **Rule 9: REGISTRATION FEES**

The registration Fee is Rs. 300/- (Rupees Three Hundred only) per team.

Rule 10: GENERAL RULES

- The Speakers shall not disclose their identities and shall only represent themselves by the team Codes allotted to them. Team codes shall be provided to each team after successful registration.
- The competition shall consist of 3 rounds i.e., Preliminary, Semi-Final & Final.
- It is mandatory to keep your college ID cards with you at the time of debate competition.
- Use of foul or obscene language will lead to disqualification.
- Participants are allowed to use any source of information during preparatory period of time. No book, document or electronic gadget shall be allowed to the participant during the competition.

• Kanoria School of Law for Women saves the right to alter or change the rules or procedures of the competition.

• The organizers shall not be responsible for any loss due to slow or non-functional internet connection during the competition.

#### **Rule 11: COMPLAINT PROCEDURE**

• If a team believes that violation of any of the Competition Rules has taken place at any stage of the Competition, the teams shall within half an hour of the completion of the round wherein a violation has allegedly occurred, register a complaint with Organizing Committee Under no circumstances are the teams allowed to approach the Judges with any complaints.

#### **Rule 13: VIDEO CONFERENCING RULES**

• All the rounds for the competition shall be conducted virtually. The video conferencing platform would be informed well in time through email.

- The Link of Meeting ID and schedule will be informed to the teams through email.
- All the participants shall keep their microphone on mute at all times, except when addressing arguments. Speaker will unmute his/her microphone only after being invited to do so by the moderator and Judges.
- The speaker must keep their camera on while presenting the argument.

• The participants shall report at least 15 minutes before their scheduled time.vi. The organizers shall not be responsible for any loss due to slow or non-functional internet connection during the competition.

• Disclaimer: The Rule shall be strictly adhered to. The organizers reserve the right to disqualify teams for deviating from the rules. The Organizers will resolve any contingencies that may arise and will be the final arbiters regarding any doubts/ grievances. The decision taken by the Organizers shall be final. These Rules are not exhaustive.


