 - b. RTI Drafting
 - c. Consumer Complaint Drafting
- 2. Each participant is required to prepare Only One Draft in handwritten form only.
- 3. Participants will be intimated about the drafting problem (PIL/RTI/Consumer Complaint) via email on Sunday, June 9, 2024 at 10-25 am.
- 4. Total duration for preparing draft is One and Half Hrs. (10-30 am to 12 noon.)
- 5. Participants will have to upload handwritten draft on google form shared in email on or before 12 noon.
- 6. Drafts will be evaluated based on the parameters viz. Format, Content, Legal Provisions involved, professionalism.
- 7. Late submission will not be considered in any circumstances.
- 8. Result of the competition will be declared by June 25, 2024
- 9. Decision of the organizer will be final and binding
