- **1<sup>st</sup> May, 2024 (From 10:00 AM onwards)**

Students can apply online for Summer Internship Program -2024 through DSLSA's official website i.e. [www.dlsa.org](http://www.dlsa.org).

- **15<sup>th</sup> May, 2024 (Till 5:00 PM)**

Last date for submission of applications. Application should be submitted with scanned copy of Identity Card issued from College/University & passport size photograph of the applicant alongwith recommendation letter issued by principal/HOD of Law Department. In case desired documents are not attached, then application will not be considered. & a Statement of Purpose for doing Internship written by the Student/Applicant himself/herself in max. 70 words.

- **25<sup>th</sup> May, 2024**

Students will be shortlisted and selected on the basis of their expression of interest through the Statement of Purpose submitted with the application and draw of lots, if more than required applications are received. The shortlisted students will be informed about the same.

- **30<sup>th</sup> May, 2024 (Last Date for giving Willingness)**

Students shall however send a confirmation e-mail @ [legallitwing-dlsa@nic.in](mailto:legallitwing-dlsa@nic.in) of their participation in Internship Program positively latest by 30<sup>th</sup> May, 2024, failing which their application is liable to be rejected.
