3. Fundamentals of Law/ Integration of all Laws

The students shall be explained the object, rationale and concept of major laws including Constitution Law, Indian Contract Act, Sale of Goods Act, Specific Relief Act, Code of Civil Procedure, Code of Criminal Procedure, Indian Evidence Act, Limitation Act, Registration Act, Suit Valuation Act and Court Fees Act, Indian Penal Code, Pleading and Conveyance, Motor Accident Compensation Law, Consumer Protection Act, Arbitration and Conciliation Act, Transfer of Property Act and Rent Laws, Hindu Marriage Act and Special Marriage Act, Indian Succession Act and Hindu Succession Act.

4. Program Duration

Duration: August, 2024 to December, 2024

- Off-line lectures and discussions that include various activities and exercises.
- On-line individual and small group interactions with Justice Midha and Faculty Consultant.
- Consultations with Program Coordinators.

5. Eligibility and Selection Process

The Mentorship Program is open to Law Students of the Galgotias University. The selection process shall entail two stages. At the first stage, interested students are required to submit an application form, including a Statement of Purpose (SoP), highlighting the reasons for which they want to be part of the program. The candidates shall be shortlisted on the basis of their applications. At the second stage, the shortlisted candidates will be subject to an interview pursuant to which the selected candidates shall be notified.

6. Evaluation Scheme

The participants will be assigned practical exercises and case studies to apply their knowledge and develop their analytical and problem-solving skills. The participants shall be evaluated on the basis of attendance and participation in Off-line and On-line interactions; timely submission of the assignments; quality of the work submitted. The participants are required to keep the faculty advisors apprised of their assignments and related exercises.
