# ABOUT INTERNATIONAL FACULTY DEVELOPMENT PROGRAMME (IFDP)

The Centre for Continuing Legal Education at School of Law, Bennett University, Greater Noida has organised “Two Weeks Online Refresher Course on Criminal Law, Corporate Laws and Labour Laws” from 30th May 2022 to 13th June 2022. The Centre has also organised first International Faculty Development Programme (IFDP) from 29th May 2023 – 3rd June 2023 on the theme: “Outcome Based Education: Changing Dimensions of Law Teaching and Research” wherein renowned academicians from National and International Universities of repute have provided training and deliver expert talks on various topics related to the theme.

The main focus of the IFDP this year is on theme “**Innovative Techniques of Teaching and Research in Law**” from **22 July 2024 to 27 July 2024** to enhance the professional skills of members of legal fraternity on a global scale. The broad aim of the programme is to improve the quality of legal education offered by various national and international institutions and contribute to a more informed and engaged global legal community. Henceforth, the proposed International Faculty Development Programme is an attempt to achieve the following objectives:

1. To improve teaching methods by inclusion of innovative techniques to make law courses developed by faculties more engaging and effective for students
2. To develop research skills by providing training on cutting-edge research methodologies to contribute to the high quality of research.
3. To promote international collaboration by fostering exchange of ideas and best practices among law faculty members and scholars.
4. To update participants on legal trends and the latest developments in legal education and global legal issues.
5. To incorporate technology and equip faculty with the skills to leverage technology effectively for teaching and research purposes.

## Sub- themes

The International Faculty Development Programme will be conducted on following thematic areas:

1. Innovative Methods and techniques of teaching and research in law
2. Integration of technology using digital tools for enhanced learning
3. Strategies for promoting active participation and peer learning in the classroom
4. Developing creative and effective methods for assessing student learning outcomes
5. Techniques to cater to different learning styles and cultural backgrounds in a classroom
6. Exploring both traditional and non-traditional research methods relevant to law
7. Legal Data Analysis by Quantitative and Qualitative Legal Research
8. Training on using legal databases and statistical software for research
9. Interdisciplinary approaches to legal issues from the perspective of other disciplines
10. Exploring the impact of emerging technologies like AI on legal teaching and research
11. Building partnerships between faculty members from different countries to tackle global legal challenges.
12. Utilizing technology to create online courses and publishing in International Journals.

## LEARNING OUTCOME

1. Participants will be able to design and deliver law courses using engaging and effective methods like problem-based learning, simulations, or flipped classrooms.
2. Participants will develop strategies to foster student participation, discussions, and critical thinking in their law courses.

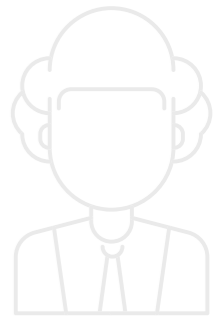
