- The papers must have a word count of approximately 5000 words, which includes the abstract, references, Times New Roman with a 12 front size, line spacing of 1, headings in Times New Roman with a 14 front size, and subheadings in Times New Roman with a 12 front size in italics.
- The papers must be submitted in Microsoft Word format only.
- Originality, coherence, thoroughness, and contribution to discourse and knowledge will be taken into consideration for selecting papers.
- Full papers that are chosen will be invited for presentation and publication with a reputed publisher with ISBN.
