SUBMISSION PROCEDURE:

1. Submissions are welcome from academicians, professionals, lawyers, social workers, members of civil society organisations, legislators, students, and/or anyone who has a deep interest in the subject.

2. The abstract (of about 250 words) should be sent as an attachment. After acceptance of the Abstracts, the author(s) shall be required to submit the complete paper within the stipulated time.
3. The submissions must be accompanied by the following information:
 - Full Name of the Author(s)
 - Designation
 - Institutional Affiliations (if any)
 - Contact Details of the Author(s) clearly explaining the topic and objectives of the proposed chapter.
4. All the submissions must be made in **.doc/.docx** formats only.
5. All manuscripts will be accepted based on a double-blind peer-review editorial process.
6. There shall be a rigorous review process. The editorial board will ensure a greater standard of review and identification of quality academic writing. The authors shall be intimated about the status of their manuscript at every stage.
7. The decision of the editorial board regarding the manuscript shall be final and binding. They reserve the sole rights to the publication of the selected chapter in addition to, inter alia, any edits/amends/reproduction.

PUBLICATION GUIDELINES:

The contributors must follow the guidelines mentioned below:

1. Any manuscript not meeting these guidelines will be returned to the author(s) for correction, which may cause significant delays in the publication process.
2. Word Count for the book chapter- 5000 to 7000 (excluding reference).
3. Only **ORIGINAL** submissions will be accepted for publication. Manuscripts should not have been previously published or be submitted for publication elsewhere. Manuscripts should be submitted in Times New Roman, with font size 14 for title, 14 for headings and 12 for body text, line spacing 1.5; justified, with justified margins on all sides.
4. Manuscripts can be in the form of chapters. 'Chapter' refers to a comprehensive and thorough analysis of issues related to the theme/sub-theme of the Book.
5. Co-authorship is permitted, but there can be a maximum of two authors.
6. Preferred referencing style to be followed: **APA (7th Edition)**.
7. The chapter shall go through a strict plagiarism check, and the plagiarism shall not be more than the prescribed limit of the University Grant Commission Rules. Any paper exceeding 10% similarity shall be outrightly rejected.
8. The author shall be solely responsible for plagiarism if it is detected before or after the publication of a book chapter.
