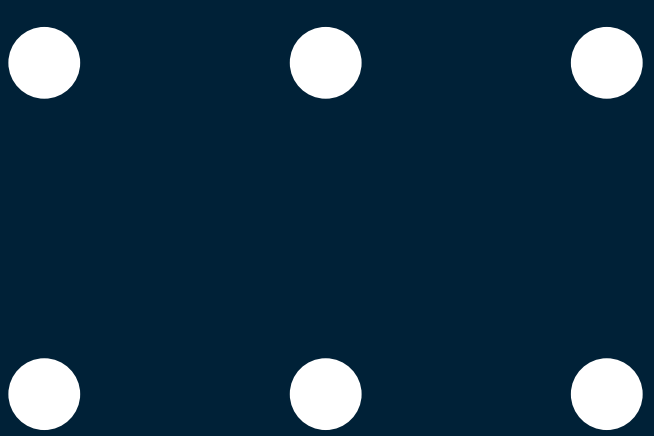

- The manuscript should be in English language and shall be written in Times New Roman with Font size 12 and 1.5 line spacing.
- The word limit of full paper must not exceed 5000 words excluding abstract.
- The manuscript should be in English language and shall be written in Times New Roman with Font size 12 and 1.5 line spacing.
- The permitted plagiarism is 20% for the full paper.
- Footnotes should be in Times New Roman, size 10, single line spacing.
- Citation: Bluebook 21st edition
- Margin of 4 cm shall be left on all sides of the paper. Page borders shall not be used.
- The manuscript should be checked thoroughly for grammatical or typographical errors before submission.
- The manuscript should accompany a separate cover page to provide title of the paper, author's name, designation and email ID.
- The limitation to the number of co-authors on a paper is two. After peer review process, selected papers will be published in Book Chapter with ISBN publication.
