



NATIONAL BLOG WRITING COMPETITON ON CONSUMER RIGHTS

The National Blog Writing Competition aims to highlight the essential right of legal aid, guaranteed under Article 39A of the Constitution of India, which promotes justice based on equal opportunity. Focusing on consumer rights, the event seeks to bridge the gap in understanding and exercising these rights, addressing everyday disputes that often go unregistered due to a lack of awareness. The competition provides a platform for law students to express opinions, share experiences, and enhance research and analytical skills. Participants should register and submit their entries via Google Forms, and the evaluation process will be based upon certain criteria's like the flow of language, critical thinking, analysis, title of the paper, etc. Winners receive cash prizes and Certificates of Excellence through online payment, while all participants will receive e-certificates. The event's outcomes include the establishment of a lasting resource on consumer rights, increased awareness, a platform for discussion, and influence on public opinions and policymakers for better consumer protection practices.

Blogs must be submitted in Docs or PDF format. Submissions through the provided Google form (sent via email).


