PAPER PRESENTATION GUIDELINES

1. The Conference shall have paper presentations that shall be selected after a blind review procedure to be conducted by the editorial board.
2. The presenters will present their papers before a panel of experts who shall adjudge the paper presentations.
3. The participants may adopt any suitable means for presenting the papers including Audio-Visual aids, Power Point Presentations etc.
4. In case of co-authorship at least one author must attend the conference to present the paper.

SUBMISSION GUIDELINES

- **Language:** All submissions must be in English language.
- **Word Limit:** The abstract should be between 250-300 words along with 5-7 keywords. The full research paper should be between 4000-5000 words (inclusive of all citation and references/footnotes).
- **Font and Line Spacing:** Submissions must be typed in Times New Roman, Font Size 12 on A4 size paper with 1-inch margin on all sides with 1.5-line spacing. Potential contributors are required to adhere to a uniform mode of citation (20th Edition of The Bluebook: A Uniform System of Citation). It shall be submitted in MS-Word file.
- **Registration:** Submission of the abstract will be considered as a provisional registration and the co-authors are also required to get registered for the conference.
- **Abstract Submission:** Abstract of the paper should be submitted through google form on or before 26th August, 2024 at 11:59 P.M. IST through below mentioned link.
