# ABSTRACT GUIDELINES

- The participants are requested to submit an abstract of a maximum 300 words in the doc./docx. format, font style – (Italic) Times New Roman, font size – 12, line spacing single.
- Author(s) must refrain from revealing their identity in any form in the abstract.
- Authors are required to mention their details (name, designation and employer/organisation) in the cover letter/body of the mail. It is reiterated that the author's identity must not be revealed in the .doc/.docx file containing the abstract in any form or manner.
- The abstract must pertain to any of the sub-themes of the conference and must include a clear indication of the objectives, methodology, major results, and implications.
- Abstracts have to be submitted at [ccvconference@nludelhi.ac.in](mailto:ccvconference@nludelhi.ac.in) with the subject titled "Abstract Submission - 2nd VSA Conference" latest by 11.59 PM on August 31, 2024.
- All abstracts will be subject to blind review and only those abstracts approved by the reviewers will be selected to submit their full paper for the final presentation.
- The criteria for evaluation by the reviewers are based on Relevance, Methodology and Originality.
- Authors whose abstracts are selected will be intimated of the same within 15 days after submission. i.e. by 11.59 pm, August 31, 2024.
- **Registration & Payment link will be shared separately if abstract is selected.**

NOTE: The author/co-authors of selected papers will be invited for a Paper Presentation at National Law University, Delhi on 9-10 November 2024. The University will provide support to the participants with the Invitation Letter or any other document as required for visa processing.





# FULL PAPER SUBMISSION GUIDELINES

- The authors whose abstracts are selected will be intimated separately about the further payment process through email.
- The soft copy of the full paper must be submitted in .doc/.docx format to [ccvconference@nludelhi.ac.in](mailto:ccvconference@nludelhi.ac.in) by 11:59 PM, 15th October 2024 with the subject "Full Paper Submission".
- Formatting Guidelines:
  1. Word limit – 5000
  2. Font style – Times New Roman
  3. Font size – 12
  4. Line spacing – 1.5
  5. Citation style – OSCOLA 4th ed. 2012
  6. Margins – 1 inch (i.e. 2.54 cm) on each side
  7. Paper size – A4

## CO AUTHORSHIP

- Co-authorship is allowed subject to a maximum of 02 authors.
- All such author and co-author(s) will have to mandatorily and separately register themselves by paying the requisite registration fees.
- At least one person amongst the author or co-authors has to be present for presenting the paper.
- In cases of co-authorship, only professionals are permitted to present the paper in the conference.

## PAPER PRESENTATION GUIDELINES

- Total Time Allocation: Each presentation is allotted a total of 10 minutes.
  - a. 7 minutes for the paper presentation.
  - b. 3 minutes for feedback and questions.
- A maximum of 10 slides is permitted.
- PowerPoint presentations (PPTs) are allowed.
- In cases of co-authorship, only professionals are permitted to present.
