PREVIOUS FACULTY DEVELOPMENT PROGRAMMES

The Faculty Development Programme in 2022 focused on "LEGAL RESEARCH AND TEACHING METHODS" and was held from August 23rd to 27th, 2022. The program addressed various critical aspects aimed at enhancing legal education:

- 1. Introduction to Teaching Methods and Research Tools: Participants were introduced to and discussed effective methods alongside essential research tools and techniques in the field of law.
- 2. Importance and Challenges of Examination: The significance of examinations in assessing student understanding and the challenges inherent in the examination system were explored and discussed.
- 3. Facilitating and Engaging Teaching-Learning Processes: Strategies were shared on the teaching and learning process more interactive, engaging, and conducive to participation and comprehension.
- 4. Data Collection, Statistical Tools, and Data Analysis: Methods and tools for collecting data in legal research, including the application of statistical tools in empirical research.
- 5. Processing, Analysis, and Interpretation of Data: Participants learned about the processes involved in processing, analyzing, and interpreting data in legal research to draw meaningful conclusions.
- 6. Research Ethics and Knowledge Replenishment: The importance of research ethics and continuous knowledge updating in legal research were underscored to maintain academic integrity and relevance.
- 7. Relevance of Indexing in Research Work: The role and significance of indexing in organizing and enhancing the accessibility of research work in the legal field were discussed.

Overall, the programme aimed to equip faculty members with advanced skills and knowledge necessary for effective teaching and impactful legal research, promoting continuous improvement and innovation in legal education. The Faculty Development Programme, 2023 titled "Dynamic Shifting of Legal Education and Teaching Techniques in Light of National Education Policy" took place from August 14th to 19th, 2023. The program focused on several key topics essential for advancing legal education:

- Reforms in Education System through NEP: Discussions centered on the reforms introduced by the National Education Policy (NEP) and their implications for legal education.
- 2. Relevance of Comparative Legal Research: Participants explored the importance and methodologies of comparative legal research in shaping contemporary legal studies.
- 3. Nature of Post-graduate Studies and Research in Law: Insights were shared on the nature, scope, and advancements in post-graduate studies and research within the legal field.
- 4. Substantive Criminal Law: Emphasis was placed on adopting nuanced pedagogical approaches to enhance student outcomes and holistic development in the study of substantive criminal law.
- 5. Developing Curriculum for Legal Education: Experts discussed strategies for designing effective legal education curricula, focusing on course design, learning outcomes, and syllabus development.
- 6. Influence of NEP 2020 on Legal Education: The impact of NEP 2020 specifically on legal education was critically examined, addressing changes and adaptations needed in academic programs.
- 7. Interplay of Technology and Legal Education in India: Sessions explored the evolving relationship between technology and legal education, highlighting opportunities and challenges in integrating technology into legal pedagogy.

The programme aimed to equip faculty members with updated knowledge and methodologies to align legal education with current educational reforms and technological advancements.
