Guidelines for Writing

- **Topics:** Submissions must fall within the realms of intellectual property, innovation, technology law, and related areas.
- **TLDR- A Short Snapshot of the Article:** An abstract of no more than 200 words must be submitted concurrently with the manuscript.
- **Author's Bio:** Author's are required to submit their short 2 lines bio along with the article
- **Language:** All submissions must be in English.
- **Co-Authorship:** Co-authorship is permitted for up to a maximum of three authors.
- **Formatting:** The body of the paper should be in Times New Roman, font size 12, with 1.5 line spacing. Footnotes should be in Times New Roman, font size 10, with single line spacing. Follow the APA style of citation for all references.
- **Originality:** All submissions must be original, unpublished, and not under consideration by any other journal or forum.
- **File Format:** Submissions must be made in MS Word or Open Word format (*.doc or *.docx).
- **Visuals:** Authors are encouraged to include tables, charts, graphs as visualization, and relevant figures where appropriate. Proper citations and referencing a must.
- **References:** Use hyperlinks for references where possible, directing readers to more detailed reports or other research. Open access sources are preferable to those behind paywalls. Hyperlinks should be included at the relevant point in the argument. Follow the APA style of citation for all references.

- **Theme Consideration:** Ensure that chosen themes or arguments have not already been substantially covered in past articles or contemporary discourse. However, responses or differing perspectives on existing content are welcome.

Review Process

Submissions are accepted on a rolling basis.

IP Wave shall provide reviews within a week of submission.

Submissions not conforming to these guidelines may be rejected without review. While we strive to provide substantive feedback for every submission, it may not always be possible given the volume of submissions.

Appreciation

Authors whose submissions are accepted for publication will receive a letter of appreciation from the Research Director of the Advanced Study Institute of Asia and Prof. Unnat P. Pandit, the Controller General of Designs, Patents, and Trademarks, and Registrar of Copyright and Geographical Indications, Govt. of India.

Types of Submissions

Long Articles: In-depth articles of about 1500-3000 words analysis on intellectual property, innovation, and technology law. Should provide insightful commentary on contemporary legal developments, including topical issues, recent judgments, and legislative changes.

Short Posts: Shorter pieces of about 1000-1200 words making novel points or offering new interpretations of existing law. Should be engaging and accessible to a broad audience. Blog posts may be co-authored by a maximum of two authors.

Book Reviews: Engaging reviews of recent literary works related to intellectual property, innovation, and technology law.

- All submissions will be subjected to a plagiarism check, and works with more than 10% similarity may be rejected.
- Authors must ensure that their work does not infringe on any copyright. Proper attribution and citation of sources are required.
